SUBJECT: Bolivar Park

RECOMMENDATION

The Parks, Recreation and Culture Department recommends that:

- 1. Council receive this report as information,
- 2. Council adopt the Preferred Concept Plan (Appendix 3) for future development of neighbourhood amenities in Bolivar Park; and,
- 3. That staff be directed to follow the course of action described in Option 2 of this report (not install field lighting at Bolivar Park).

INTENT

At the Regular Council meeting of July 10, 2006, Council received Corporate Report No. R148 regarding field lighting at Bolivar Park. After receiving the report, Council directed staff to carry out additional public consultation regarding the Park. The intent of this report is to provide Council with an overview of the results of the community consultation that has taken place since July 10, 2006, and to obtain Council direction with respect to the future development of amenities on the park site.

BACKGROUND

In the spring of 2006, Council approved a park development capital project to provide field lighting of Bolivar Park Ball Diamonds 1 and 2, in the amount of \$542,000 to be funded from anticipated 2006 one-time operating savings. Following standard practice, a public meeting was held to receive comments from the local community about the project. The majority of those attending the meeting opposed the project. A memo was sent to Council on June 6, 2006 in which community concerns were documented and suggestions for mitigating the concerns were laid out.

On June 26, 2006 a delegation of residents from Bolivar Heights appeared before Council to express their continuing concerns about the lighting project.

At the Regular Council meeting of July 10, 2006, Council received Corporate Report No. R148 (Appendix 1) regarding field lighting at Bolivar Park. After receiving the report, Council directed staff to carry out additional public consultation.

DISCUSSION

Summary of Public Consultation Meetings

<u>August 3, 2006</u> - Staff met with twelve individuals who represent Bolivar Heights residents who were opposed to the field lighting project. In the meeting, the residents unanimously agreed that the most important concern to them was that no field lighting be constructed at Bolivar Park. In addition to this concern, the issues of noise, the number of and operation of beer gardens, consumption of liquor in the stands and dugouts, litter and garbage in the park, traffic, street parking, public urination and access to the park facilities were also discussed. A commitment was made by staff that efforts would be made to address the concerns of the residents, and that law enforcement staff would be invited to the next community meeting.

<u>August 8, 2006</u> - Staff met with the executive board of the Bolivar Slo-pitch Society. The concerns of the residents were outlined for the Society, and discussion ensued about ways in which the Society could operate the park that would mitigate the concerns of the residents. The Society voiced concerns about the negative behaviour of some residents, including dogs off-leash in the park and in the fenced diamonds and rude behaviour to spectators and players. The Society also noted that some residents in the neighbourhood favoured lighting the diamonds, and that the resident's group did not represent all areas residents. The Society stated that they would compile a written list of their concerns and present these back to staff; however, no list has been presented to date.

<u>August 10, 2006</u> - By-law Enforcement staff and Parks staff met again with the same residents that attended the August 3, 2006 meeting. The residents were updated on the action taken by City staff since the August 3 meeting, and on the efforts of police and by-law staff in dealing with enforcement issues at the park. The residents seemed pleased by the progress to date on these issues. A mechanism was outlined for the residents to ensure that they had a reliable, timely means of contacting Parks staff for future complaints about problems at Bolivar Park. The residents were advised that additional community consultation would take place in the autumn about future development of Bolivar Park to create amenities that would assist in meeting the needs of local residents. They were also advised that staff would be reviewing the Operating Agreement with the Society to ensure that key issues of concern for the local community were adequately addressed within the Agreement.

<u>September 14, 2006</u> – Based on community concerns about the shortage of neighbourhood amenities in Bolivar Park, staff hosted an open house to determine what improvements could be made in the park to better meet local resident needs. Standard procedures were followed for the open house, including a local mail out and advertisements in the Surrey Leader and City web page. Approximately 45 residents from 29 households attended the open house and 47 comment sheets were returned by September 25, 2006.

The information on display included background information about the park and the softball diamond lighting proposal, the existing park conditions and context, opportunities and constraints for park improvements, a revised park concept plan, and improvement ideas for the park. The suggested park improvements included playground upgrades, entry features, a sports court, a picnic and events area, a boardwalk and trails through the natural area, upgrades to the eastern portion of the park including

a look out, a designated neighbourhood dog-off leash area, an asphalt perimeter walking loop around the ball diamonds, buffer planting for residents, and specimen tree planting.

At the open house, residents were encouraged to give input and prioritize the improvements that they would like to see in the park in the future. The input received indicated that the top three priorities for improvements are the children's playground, a boardwalk and natural area trails, and a picnic and events area. The feedback received from residents was very positive, as follows:

- 83% of participants strongly supported or support the concept plans as presented
- 2% of participants neither supported nor opposed the concept plans as presented
- 6% of participants strongly opposed or opposed the concept plans as presented; and
- 9% of participants had no response

October 12, 2006 – A second Open House was held to inform residents of the results of the September Open house, to confirm priorities for park improvements, and to finalize a preferred park concept plan. The information on display included a summary of the findings of the first open house, a preferred park concept plan, and detailed plans and cost estimates for the top three park improvement priorities. A total of 53 residents from 41 households signed in at the Open house and 45 comment sheets and 1 letter were returned by October 27, 2006.

The following is an overview of the written comments gathered at the second open house:

- 60% of respondents strongly support or support plans as presented
- 24% of respondents neither supported nor opposed the plans as presented
- 14% of respondents strongly opposed or opposed the plans as presented; and
- 2% had no response

A review of the comments received indicates that less support for the proposals was shown at the second open house because some residents disagree with the priority ranking of the improvements, and because some residents continue to express concern with the operation of the park and the proposed softball diamond lights.

It is important to note that 60 of 92 comment forms (65%) from the two open houses combined had negative comments about the impacts associated with lighting the fields.

Operation of the Park

Following the first meeting with area residents on August 3, 2006 "Alcohol Prohibited" signs were prominently placed in the ball diamond dug-outs, at the spectator viewing areas, in the parking lot and at other prominent locations within the park. In addition, when prompted by By-laws staff, the Society voluntarily changed their web site so that it no longer inferred that alcohol could be tolerated at the park if it was contained within plastic cups. Signs were also posted to indicate that motorcycles and other vehicles are prohibited on the pedestrian bridge and on park trails. Both the RCMP and By-law Enforcement staff increased their presence in the park during July, August and September, 2006. The prominent signage, increased level of self-policing by the Society, and increased presence of law/by-law enforcement officials, resulted in a dramatic reduction in complaints relating to liquor infractions. Also, some residents have noted a definite reduction in litter, noise, public urination and parking problems.

Staff has initiated a formal review of the Society's Operating Agreement. Unfortunately, as of November 29, 2006, the Society has not complied with numerous verbal and written requests from

staff to produce financial records and information pertaining to park utilization and field bookings. This information is key to understanding if the present arrangement whereby the Society pays the City to maintain the park site is a better financial situation than having the Society pay the City for all of the time booked on the fields. This issue will be pursued and it is anticipated that a new Agreement will be struck in the winter of 2006-07. It is likely that the new Agreement will be a more traditional type of agreement, such as those in place at Cloverdale Athletic Park, Newton Athletic Park, South Surrey Athletic Park, Royal Kwantlen Park, etc. At these sites, the groups maintain the public change rooms and washrooms, and carry out other minor maintenance, in exchange for retention of 100% of the revenues from concession operations. At these sites, the groups using the fields pay all relevant field user fees, and the City maintains the park infrastructure.

In addition to the analysis that will be undertaken by Parks staff relative to the Operating Agreement, the Beer Garden Committee will be convened over the winter to discuss past performance of beer garden operations at Bolivar Park. This discussion will lead to recommendations being made to Council with respect to the number of Beer Garden License Days being approved for Bolivar Park in 2007.

Future Development

Based on the responses from the Open Houses, a preferred Concept Plan (attached as Appendix 3) has been identified and it is recommended that this Plan be adopted by City Council. If adopted by Council, park improvements will be phased in over a number of years, leading to a finished park that meets the needs of both playing field users and local residents. Based on the community consultation process, the park amenities with the highest priority for local residents are: improvements to the playground; development of a boardwalk and natural area trails; picnic and events areas; repair drainage on Diamond No. 4; and buffer plantings between the active playing field area and residences to the south. Phase 1 improvements are anticipated to cost approximately \$350,000. Some funding to commence installation of these priority improvements at Bolivar Park will be proposed within the 2007 portion of the 2007-2011 Five-year Financial Plan.

Demand for Adult Slo-pitch Diamonds and Tournament Facilities

During the 2006 season, only 52% of the players who used the Bolivar Park slo-pitch facilities were Surrey residents.

In the past two years, all of the demands for increased tournament capacity for adult slo-pitch has come from the Bolivar Slo-Pitch Society, who would like to expand their operations and provide opportunities for international level slo-pitch tournaments. The Society has hosted numerous successful tournaments in the existing facilities. Although the Society has indicated that there are many opportunities to bring larger scale tournaments to Surrey, to date it has been difficult to determine the requirement on lighting as a critical factor to attract larger scale events. Softball City in South Surrey also hosts a number of large scale tournaments, although the facility is well utilized it is not currently at full capacity for tournament play.

Lighting Impact on Projected Game Capacity Increases

The installation of lighting in two fields at Bolivar Park at a cost of \$542,000 would provide additional capacity of one game per diamond per day from mid-May to mid-July and two additional games on each diamond in the April to mid-May and the mid-July to mid-September time period (approximately 50% of additional game time). Significant additional capacity would be obtained for the other colder seasons of the year, but it is not clear how much uptake there would be of the

evening times during the fall, winter and early spring seasons. Field lighting is typically a cost effective means by which to add to field capacity in comparison to constructing new fields provided that the impacts of the lighting can be addressed.

If two additional unlighted adult slo-pitch diamonds were to be built at another nearby location to increase the tournament capacity at Bolivar, the cost, inclusive of site preparation, site servicing, parking, fieldhouse construction, ball diamonds construction and landscaping would be in the order of \$2.3 million. Land costs have not been included in this estimate. Land with an area of 3.8ha would be required to accommodate 2 ball diamonds.

Options for Field Lighting

1. Install field lighting at two diamonds at Bolivar Park in early 2007, at an approximate cost of \$542,000.

Pros – This will provide cost-effective additional game capacity at Bolivar Park, and would be especially useful for rescheduling of rained-out daytime games to the evening hours during large tournaments. This would also allow the scheduling of evening games through other months of the year to get higher utilization of the ball diamonds.

Cons – For reasons relating to noise, light pollution, increased neighbourhood parking, increased traffic, and year-round utilization of the park, many residents in the Bolivar Heights area are strongly opposed to development of field lighting.

2. Do not install field lighting at Bolivar Park. As part of the Parks, Recreation and Culture 2007 Strategic Plan process, explore the demands for, and options related to, the development of additional high quality ball diamonds in the Bridgeview or South Westminster area, such that very large tournaments could be scheduled on fields in relatively close proximity to one another. This demand could then be quantified and prioritized along with the demands for other recreational facilities brought forward as part of the 2007 Strategic Plan.

Pros – This option would be acceptable to the residents of Bolivar Heights, and would place the demands for additional adult slo-pitch diamonds in context of other demands across the city for varying new park facilities, recreation complexes, and cultural facilities, programs and services. Further, this is consistent with a proposal advanced by the Bolivar Slo-pitch Society at the Parks and Community Services Committee at their November 2006 meeting.

Cons – The Bolivar Slo-pitch Society will be concerned that they may not be able to attract the scale of tournaments to the park that they have been hoping to in the 2007 season. The principal loss to the City would be in tourism revenue associated with teams visiting from outside the City of Surrey.

CONCLUSION

Council has considered providing field lighting at Bolivar Park. Due to significant concern about the project from residents living near the park, Council asked for additional community consultation prior to making a decision in this matter.

Five meetings were held to gain a better understanding of the views of the community regarding the field lighting project and other future development at the park that would provide amenities for local residents. Based on input from these meetings, a Preferred Concept Plan has been developed for Council approval.

Information important to the operation of the park was learned at the community consultation meetings, and a number of changes were subsequently made that will allow the park to function more effectively. In addition, the operating agreement with the Society will be reviewed in the winter of 2006-07, with the intent of developing a new agreement that will deal with user fees, maintenance responsibilities, and other issues that are important to the community. A formal review by the Beer Garden Committee will be undertaken, and recommendations will be brought back to Council respecting 2007 beer garden allocations for Bolivar Park.

Based on the above information, Staff do not recommend the installation of field lights at Bolivar Park, however repairing drainage on Field No. 4 and the provision of some additional park amenities for residents living in the vicinity of the Park are recommended. Funding for this work is included in the 2007 budget (as proposed).

RECOMMENDATION

That Council:

- 1. Receive this report as information.
- 2. Authorize the City Clerk to forward copies of this report to the Bolivar Park delegations, along with the related Council resolution.

INTENT

The intent of this report is to provide additional information to Council regarding the proposal to install field lighting on two ball diamonds at Bolivar Park, following the Council-in-Committee meeting of June 26, 2006.

BACKGROUND

In the Spring of 2006, Council approved a Park Development Capital Project to provide field lighting of Bolivar Park Ball Diamonds 1 and 2, in the amount of \$542,000 to be funded from anticipated 2006 one-time operating savings. Following standard practice, a public meeting was held to receive comments from the local community about the project. The majority of those attending the meeting opposed the project.

On June 26, a delegation of residents from Bolivar Heights appeared before Council to express their continuing concerns about the lighting project. Some of the key concerns expressed by the delegation were:

Light pollution spilling from the park into the residential neighbourhood;

- Extended operating hours of the park associated with the lighting would negatively
 impact the resident's peace and quiet throughout the year;
- Inadequacy of the treed buffer, especially in the autumn and winter when the leaves are off the trees;
- Increased traffic on local streets and parking issues associated with elevated use of the facility;
- · Consumption of alcohol at the park by ball players;
- Urination in the treed buffer by ball players;

DISCUSSION

Appendix 1. Contains suggestions for mitigating the impact of a number of the concerns raised by the residents. With respect to the operating issues currently associated with the park, staff have met with the Bolivar Slo-Pitch Society (the Society) to review their obligations under the existing Operating Agreement. Staff reinforced the need for the Society to institute various controls to ensure that ball teams that use the park adhere strictly to the rules of conduct outlined in the City's by-laws, policies and permit regulations. Further, both the RCMP and By-law Enforcement have stepped up their monitoring of the park to ensure that the park is being utilized appropriately and in accordance with the law.

The following points provide additional information that may assist Council in making decisions regarding this project.

Treed Buffers Between Lighted Fields and Nearby Residences

The delegation compared the width of buffer at Bolivar Park with the width of buffer that separates the lighted diamonds at Softball City from the residential neighbourhood to the east, explaining that Softball City had a far greater buffer width. Drawings of Bolivar Park showing the width of the treed buffer are contained in Appendix 2.

The trees that exist on the south side of Bolivar Park were left in place primarily to satisfy environmental requirements related to a red-coded stream that runs through the park. Sound and visual buffering provided by the treed area is a secondary benefit for the residents of the area.

The width and nature of buffers between lighted fields and nearby residences varies considerably from park to park, and are not seen as an absolute requirement. For example, some parks such as Cloverdale Athletic Park do not contain treed buffers between the lighted fields and adjacent residences. At Royal Kwantlen Park, the lighted field has a treed buffer on its west side, but no buffers on its other sides. At South Surrey Athletic Park, treed buffers between the seven lighted fields and adjacent residences range from 48 meters to 65 meters.

Projected Increase in Ball Diamond Game Capacity

Lighting two diamonds will provide additional capacity for evening play at Bolivar Park. In June and July, when the day length is longest, it is likely that only one additional game could be played on each diamond during the evening hours over the present situation with unlighted diamonds. In May and August, it is likely that two additional games could be played on each diamond each evening. In the remaining months of the year, cooler night-time temperatures may limit play somewhat, but the capacity of the diamonds would be dramatically increased. Staff have calculated that the lighting of two diamonds at Bolivar Park will increase the capacity for play by an additional 390 games per year, representing a 50% increase in total game capacity, or the equivalent of two additional diamonds. (Each un-lighted diamond has an annual capacity of approximately 195 games) However, it should be noted that the increased capacity would not necessarily be fully utilized in the near future.

During summertime tournament events at some other lighted four-diamond complexes such as Softball City, the lighting is used primarily for rescheduling rained-out daytime games, and for play-off games that run long. Few evening tournament games are scheduled under the lights.

The Bolivar Slo-pitch Society was asked to document their critical need for field lighting to increase the capacity of the park. In response, the Society has provided a letter in this regard, attached as Appendix 3.

Numbers of Surrey Residents Presently Utilizing Bolivar Park

Bolivar Park serves the needs of league play and tournament play. Based on figures provided by the Bolivar Slo-pitch Society, it is estimated that approximately 8,500 players will use the park for games during 2006. Of these players, approximately 52% are Surrey residents. Therefore, the park serves the needs of approximately 4,400 Surrey resident adult slo-pitch players annually.

Competing Ball Facilities in Other Communities

Lighted four-diamond complexes are located at Softball City in South Surrey, in Langley, in Abbotsford and in Ridge-Meadows; staff are not aware of other lighted four-diamond complexes within the lower mainland.

Previous Complaints from Neighbours

In e-mail correspondence received following the public open house, residents had complained that their concerns about the operation of the park had been ignored. This is at odds with city records. The City's records show only a few complaints about the operation of the park over the years since the park was constructed. When staff discussed this issue with the residents, the residents explained that most of their complaints about noise and poor behaviour by players had been made to the RCMP or to Firebase through the Engineering after hours number; as the complaints were not considered by these agencies to be emergencies, no action was taken by them and Parks staff were not notified.

Bolivar Park - An Athletic Facility Planned For Future Lighting

When development of Bolivar Park was first being planned in 1996, information was presented verbally at the open house regarding future plans to light the four ball diamonds. In the second open house held in 1998, the lighting was again discussed as a future option.

Revenues Generated by the Society

The Society generates revenues through league and tournament fees, and through the sale of products at beer gardens, which in many ways is similar to the operation of Softball City by the BC Amateur Softball Association. Proceeds from these sources is used for several purposes:

- Investment in Capital Infrastructure The Society purchased and installed the main washroom/storage room/concession facilities at the site, and is working with the City toward the development of additional washroom facilities at the park;
- ➤ Covering Operating Costs The Society pays for graffiti control, electrical / plumbing / structural repairs, field maintenance, litter control, utility costs, etc. This will amount to approximately \$25,000 in 2006.

Following its normal practice, the City will be undertaking a comprehensive review of the Society's revenues and expenses during 2006, and will adjust the operating agreement as necessary to ensure that the City continues to get good value through its partnership with the Society.

Options For Consideration By Council

The following options are available to Council regarding Bolivar Park:

Option 1 - Proceed with Lighting Two Diamonds

Under this option, game capacity at the park would be increased by approximately 50% at a cost of approximately \$542,000. Staff would continue to work with the Society to ensure that park rules are adhered to in order to address operating issues that have caused recent concern in the local Bolivar community.

Pros – Game capacity would be increased by 392 games annually (50% over existing capacity, or the equivalent of two additional diamonds), providing modest advantages for running summer tournaments, but increasing substantially the opportunity for increasing league play from September through May. Lighting the diamonds at Bolivar Park is far more cost effective than constructing a new two-diamond park in the vicinity (currently estimated at \$4,300,000 including land costs) or upgrading the existing poor diamonds at Bridgeview Park (currently estimated at \$1,355,000). The improvements carried out in 2007 would assist in meeting community expectations, and would improve the safety and playability of field No. 4.

Cons – This option is unlikely to satisfy the majority of residents who live in the Bolivar Heights neighbourhood, with respect to their various concerns related to the lighting proposal.

Option 2 - Do Not Install Lights

Under this option, lights would not be installed.

Pros – This option would eliminate the concerns expressed by the neighbourhood in regards to lighting the field.

Cons – Additional capacity for extended league play will be reduced, and the ability to attract and host larger tournaments would be more limited.

Action to be taken at Bolivar Park

A planning exercise will be undertaken in the autumn to determine what amenities could be constructed in the park to better meet the needs of local residents. Staff will also carry out works on Diamond No. 4 in 2007 to deal with existing drainage problems.

CONCLUSION

A project to light two diamonds at Bolivar Park has caused considerable concern in the local community. This report provides some additional information to assist Council in its deliberations. Appendix 1 (attached to this report) includes suggestions on how many of the concerns expressed by the community could be addressed.

Based on community concerns relating to a shortage of neighbourhood amenities in Bolivar Park, a planning exercise will be undertaken in the autumn to determine what amenities could be constructed in the park to better meet the needs of local residents.

Measures to Mitigate Community Concerns

Direct Impact of Lights

The newest generation of field lights cause very little incidental light spill past the area of the fields themselves. This is due to the steep angle of the lighting, and due to advances in the ways in which the lights are shrouded. At our newest lighted field at South Surrey Athletic Park, the light cut-off is very sharp, and there have been no complaints from area residents who live across from the synthetic turf field.

Lights - Hours of Operation and Control

For facilities with sports field lights, with the exception of Whalley Athletic Park, the City's practice is that sports field lights remain on until 10:30 p.m. when there are field bookings. Some facilities provide an additional 15 minutes of sports field lighting to allow players to pack up equipment and safely leave the field. The sports field lights proposed for Bolivar Park would be controlled by an automated system that activates and deactivates the lights based on signals from the City's facility booking software. Facility users would need to enter an access code at the facility in order to confirm that the allocated time is required for use. The automated system would ensure that ball diamond lights are deactivated at 10:30 p.m. with low intensity security lights then activated for 15 minutes to allow facility user to collect equipment and exit the ball diamonds. Staff could also work with the Society to determine if there was an earlier hour at which the lighting could be shut off, in order to reduce the impact to the surrounding neighbourhood.

Noise

The topography surrounding Bolivar Park is such that sound tends to carry up the slope to residences several blocks away. Staff will continue to work with the Society to ensure that noise levels are reasonable, that any portable loud speakers and amplifiers are not utilized in non-tournament times, and that loud speakers will be directed to the north, away from the residential area if at all possible.

Traffic, Parking and Parking Lot Gate

Parking lot gates are closed at dusk for all parks except those that have lit outdoor athletic facilities (sports fields, sport boxes, tennis courts, etc.) where gates are then closed at 11 p.m. Currently the parking lot gate opening and closing is controlled by the Society. This can be modified so that the parking lot gates are open from dawn to dusk when the Society is not carrying out activities at the park, thereby providing greater access for the local community during daytime hours, and limiting non-sanctioned use of the park during some evenings.

The proposed addition of lights to two ball diamonds at Bolivar Park will likely have minimal impact on the number of vehicles at the park at any given time. There are still only four slo-pitch games that can be played concurrently at the park; however, the addition of lights will simply provide the capacity for additional games in the evening.

Staff can work with Traffic Operations and representatives of the local community to determine whether placement of "No Parking" signs in key areas (e.g. north side of 114th Avenue) will assist in meeting neighbourhood objectives related to parking control. Further, the Society will

be asked to circulate a directive to all their slo-pitch registrants, directing them to use the designated parking lot within the park, and to refrain from parking in local neighbourhoods.

Operating Agreement with the Society

The City's Outdoor Sport Facility Allocation & Management Policy states that:

"Facilities will be allocated to associations in such a way as to have a minimum of associations playing on a field or in a facility, to promote the concept of having a home field or park (except artificial turf fields"

Consistent with other community parks that contain athletic facilities, the City has established Bolivar Park as a home park for a single community sport association, the Society, with an expectation that this group will contribute positively to park stewardship, maintenance and security. The Society has been instrumental in developing sport tourism in Surrey by attracting large high-level tournaments and working with the hospitality industry in Surrey. In addition, the Society has invested in ongoing operation, capital improvements and security within the developed portion of Bolivar Park.

The facility Operating Agreement for Bolivar Park defines a list of maintenance activities that are required for the site and provides the Society with the responsibility for completing the specified works. The Agreement specifies the activities that can be carried out by Society volunteers and those that will be "contracted" to the City (who in many cases will then engage contractors). Services that are contracted to the City are then paid for by the Society. The aggregate value of the Operating Agreement is currently \$23,276 per year with \$8,358 of the works delivered by Society volunteers and \$14,918 of services contracted to the City, paid for by the Society.

To date, the Society has been diligent in meeting all financial requirements specified in the Operating Agreement. In return for the Society operating the park, the City has provided a blanket permit for all time at the facility with the responsibility for allocating individual time slots vested in the Society. In light of some of the issues that have been raised in the community consultation, staff will carefully review with the Society all its obligations of the Agreement. Staff will also review the Agreement to determine if the recoveries from the Society should be increased in light of ever-increasing use of the park.

Cleanliness

As part of the Bolivar Park Operating Agreement, the Society is responsible for litter collection and refuse removal from the park. The Society will need to fulfil this and all other requirements of the Agreement, in order to continue to enjoy the benefits that this Agreement provides to their association. Staff will increase the number of visits to the site to ensure that the Society is complying with all requirements of the Agreement.

Beer Gardens

Council has approved 49 Beer Garden Permit days for the Bolivar Slo-Pitch Society in 2006 and these will be spread over the 63 tournament days that are scheduled at Bolivar Park. Beer gardens are often a requirement for bidding for high level adult tournaments at the Provincial and National level, particularly in the sport of slo-pitch, and these are seen as an added service for tournament participants and attendees.


The City's Beer Garden Policy is a tool that is designed to limit the unauthorized consumption of alcohol in public parks by providing sanctioned times and dates where adult-sporting organizations can operate regulated and licensed beer gardens. The proceeds from these beer gardens are directed back into the parks system as the Society covers annual maintenance costs for the park and contributes to capital improvements related to the athletic facilities.

It is not anticipated that adding lights to Bolivar Park will result in requests for additional beer garden days. However, any requests received would continue go through the same review process outlined within the Policy, and would be brought forward to Council for their review and approval.

Planning for Park Amenities to Meet Neighborhood Needs

A number of park amenities indicated in the 1998 Concept Plan, including a sport box, water playground and landscape improvements have not been completed because capital funds have been directed to other important park development projects. Staff will work in consultation with local residents to finalize the details for these amenities where appropriate, and introduce new park elements for prioritization in the 2007 Park Development Capital program.

In 1999 we came to an agreement with Parks and Rec. to manage Bolivar Park. We registered Bolivar Slo-Pitch as a society Jun. 2002

Part of that agreement was to free up as much park time as possible for minor sports and other sporting group activates. The Society would cover the cost for all minor repairs and the grass cutting.

In 2000 we brought in four (4) leagues under our umbrella. Lower Mainland, Sur-Dell Men, Fall ball and Winter balt. In 2001 the Chuggers league joined, 2004 saw the Recovery League join. In 2005 teams from Newton Whalley joined. We feel that 50 or more park times have been freed up for other groups.

We also feel at this time it is critical to have lights installed at the park not only for league play but to try and free up more outside park time but also to attract quality tournaments.

Comments and Suggestions:

- > The neighbours clearly stated that this is not baseball only! Why are the soccer fields scrapped!!!
- ➤ Local residents wonder how often "they" occur. The "49 beer days" for this one park should be spread around better.
- I found it difficult to prioritize the list below because all the improvements are good ideas. Concerned about noise & vandalism.
- > No lights in the baseball diamonds. Some of the proceeds from beer gardens go towards park improvements and maintenance.
- Access to public washrooms (with improvements). NO lights. Remove diamond #4.
- Access and improve public washrooms. No lights please! Add water park please.
- Any funds raised in the park from beer gardens, 50% of profits (honest!) go to new park facilities not maintenance. No lights or speakers ever!!
- Turn ball field 4 into the area where most of the ideas below, should go.
- No lights and no sound system. Drainage is poor on diamond #4 East, so either take out east diamond to make room.
- ➤ No lights no lights, no P.A. system. More "natural trails", trails through buffer along 114 Ave this will allow getting around park when ball is being played and will stop urinating bush. Area behind diamonds 3 and 4 could be paved or graveled and made wide enough to walk through. Trails in "eastern portion" need to be groomed more often get overgrown. Also trails in lower section get overgrown.
- ➤ NO LIGHTS!
- ➤ NO LIGHTS!

- Well set up options congrats but none works if lights an option. Strongly no lights flexible on other.
- ➤ No lights No PA system. Take out diamond 4 create more open space since bad drainage anyways.

- Access to public washrooms. No lights. Public vehicle access to park (no locked gates). Remove diamond #4.
- Why weren't these forms available with the forms that were mailed out. I really like the improvements on the park but weren't they promised to us 5 years ago?
- ➤ No lights! Take out diamond 4.
- You leave us stuck with the noise from the ball diamonds. Definetly "no lights" to extend the hours and season with the use of lights is unexceptable.

- ➤ No lights! No PA System! Take out diamond 4!
- > No lights. Fenced in area (small) for beer gardens.
- Access to public washrooms!!! Once again no lights please.
- Games area is a multi-use area. No lights!
- The games court would provide the <u>variety</u> of sports activities required to make this a park for all in the community.
- Bolivar Park east is constantly being used as an "off leash" area by persons driving up (without pooper scoopers). Need garbage receptacles at east portion. There were 2 at one time in the past.
- Dogs driven to Bolivar Park @ 114 and let loose to crap everywhere no enforcement! Need garbage cans.
- > Scrap the softball warm-up area, already 4 softball diamonds. Allow ball diamond "4" to be used by the neighbourhood when not booked. * No lights!
- ➤ Thank you for finally listening to the residents. First off absolutely NO LIGHTS and NO PA System for any of the baseball diamonds. There is no need for a baseball warm up area. That is what the diamonds are for. I can hardly wait for an off-leash dog area!
- No lights no PA system. More grass areas.
- > No lighting installed period. No PA system. No beer gardens or at worst very few.
- There is no 100' tree buffer. After the leaves fall, there is zero buffer. Trees should by planted on the North side of the Bolivar Park, in front of the lumber mill, to hide the lumber and diffuse the mill noise. Picnic tables should be installed - 10 of them, so families in the area and outside the area can come as a family, and spend a day catching ball, sitting on blankets, BBQing burgers, playing tag, etc. No off leash dog area, for obvious (dog poop) reasons, families accessing the grass and existing trails already have to dog feces on the ground. Children will be susceptible to contamination. The garbage cans now, smell very strongly of stale beer. Keep the wilderness feel by not paving the paths. The children's play area is now not being used; children in attendance at the ball games wander around or stay by the area the adults are in; on numerous occasions I have seen no children in the play area. The play are does not look inviting, the items in there are non-imaginative and is secluded and has an "enclosed-trapped" feel to it. Baseball, during the spring and summer, starts very early (0800) in the mornings, daily; and runs till full dark at 10-11 p.m. (2200). After the gates are locked, 2-3 cars are outside the gate on the short road, drinking and chatting. Adults are drinking AND driving; AND some with children. Is this not against the law? As to Councillors Higginbotham and Hunt stating they were at Bolivar Park on a ball game day - the players were advised in advance, and knew to act accordingly. Same as with the City of Surrey attending – they advised the players that they sould attend, so the players and attendees knew to not expose any alcohol. Councillor Higginbotham expressed that she resides a short distance from the big Softball City in White Rock - and she noted that on their tournament eves, she could hear their noise and it did bother her as it would be short - just for the tournament. Note - Softball City has a 500' buffer zone, AND has "back boards" to further buffer the sound. Bolivar Park has less then 100' buffer, and only by the leaves of trees which will fall in the fall, and then there is 100% sound and sight passing to all homes. Every night during the spring and summer, there was elevated noise, including airhorns, until 10-10:30 p.m. Last cars would leave by 11 p.m. There is no area now where a family, or a couple. Or just kids riding bikes; can go to the park and site, picnic, throw a ball, or just have fun; all the area has been fenced into 4 enclosed and locked areas. As this is now - this "Bolivar Park" is strictly and totally for the use of the baseball leagues, there is no accommodation for any other activity. There are many families within walking distance that have young children that would like to access the area. Also children 10-12 years old, many in the area, should have access to the play area. Thank you.
- Missed the meeting. Family emergency. Is there anything online?
- ➤ I would like to see more evergreens planted behind baseball diamond #4 on the south-east hillside (between 13583 Crestview Drive and diamond #4)

- ➤ If the slo pitch has as many members as they claim (8500) a portion of <u>ALL</u> revenue should be returned to <u>New</u> developments within the park for <u>Residence use</u>. Also a member of the community association should review with the City the number of beer gardens for Bolivar Park and that unless a minimum dollar value is achieved, they are cancelled. It is almost impossible to believe the figures for 2005 beer garden revenues.
- The water park was proposed many years ago.
- The water park was proposed many years ago.
- ➤ No lights no night games.
- ➤ No night games no, no, no lights.
- Opposed to the lighting proposal. I feel we need more amenities at the park that will be of interest to the community other than baseball.
- ➤ I am still opposed to the field lighting. I am in favour of the park improvements. I am very concerned with traffic issues. Traffic cannot turn left onto King George Hwy from 132 St. Traffic is diverted off the main artery roads through our residential roads that have no traffic calming measures. This burden fall heavily on 112B Ave between 132 and 133 St.
- ➤ Would have preferred 1998 concept plan. No lights please. More control of the drinking. Please consider removing ball diamond 4.

- Family area much too small. None of these alterations will make any reductions in noise for quite some time if at all.
- ➤ Why is the road being extended? No room, more traffic and traffic noise. Buffer-zone tree area misleading it is <u>not</u> that wide at all. Dogs being delivered to Park to do their business no plastic bags with owners.
- ➤ I do support the Bolivar Park Improvement Plans, just not the order. I would still like to see an off-leash dog area as it wouldn't cost much and would keep the park clean. NO LIGHTS!

- ➤ Would like to see dog park priority higher (partly to keep that area free from parking). Would like to see games court higher.
- ➤ I would personally like to see more emphasis on games court, and access to fields, for local kids (maybe diamond #4?) but overall... great job!!
- > Is there a representative from our area to tally these votes.
- More area to walk.
- > (1.) No lights or P.A. system. (2.) Take out 1 or 2 baseball diamonds. (3.) Make play area for other sports.
- ➤ Strongly propose expanding playground also take out #3 and #4 diamond to make some more room.
- Replace deciduous trees with evergreens.
- ➤ Bolivar Park should not become the next softball city! It is a park that doesn't need paved pathways and meeting centres.

- > I think park improvements will be great for the children in the area to have a local place to go and play.
- No lights and sound systems are good news, and the planned order is okay to start with.
- > Surprised at #1 and that off leash park at #8. Also no one in the neighbourhood will use the picnic tables only ball players.
- ➤ I support the overall plan but I would like to see the completion of an off leash dog area higher on the priority list. *Also get the tree buffer in ASAP.
- ➤ Would like to see more family oriented activities take place at the park no night lights no beer gardens.
- ➤ OK but need more space. Amenities proposed are too small!
- > I'd like a longer concrete pathway for walking. I hope the pathway can go around the park.
- ➤ Playground as #1???!! Glad to see a paved walking area!
- ➤ I am shocked at the #1 on list!!! I knew a large number of people at the September meeting and the playground was not a priority for any of us.

- ➤ I also hope that these improvements attract the families and not another place for the "crack heads" to call home. We need to clean the area up for the hard working families that live in the area and shut out the King George Hwy traffic. "A safe, fun, experience for <u>families</u>."

The entire purpose of this for the baseball crowd to scream and yell around until 11 pm! The park was proposed as a sports park, not a hangout. 200 people in Bear Creek Park's picnic place make a small fraction of the noise 20 baseball patrons produce. For noise reasons, any public gathering places should be located at the north east side, close to the parking lot!
- It's supposed to be the original plan to have a water park not a diamond.
- ➤ Difficult to see the real size of the playground and what is a "meeting plaza" why is the playground the 1st priority.

I can only wish we had this much interest in this park prior to baseball's arrival, because many of us remember 114 as being Bolivar Park and not the old Whalley Driving range as being nothing more than an old piece of preload area.

- ➤ It would be nice to have access to ball field 4 when not being used for ball play. Please NO lights no P.A. system and no alcohol.
