## **EVALUATION**

Our consultant reviewed the tenders for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Imperial Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 120 working days as stipulated in the contract. Imperial's past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. We, therefore, recommend that Imperial Paving Ltd. be awarded the work.
