## RECOMMENDATIONS

The Engineering Department recommends that Council:

1. Award Contract M.S. 1705-012-11 to TAG Construction Ltd. in the amount of \$478,000.00, including 6% GST.
2. Set the expenditure authorization for Contract M.S. 1705-012-11 at \$526,000.00, including 6% GST.

## SCOPE OF WORK

Contract M.S. 1705-012-11 includes the following road projects:

## TENDER RESULTS

Tenders for Contract M.S. 1705-012-11 were received on March 23, 2007, with the results as follows:

The Engineer's pre-tender estimate was \$426,000 including GST.

## EVALUATION

Our consultant reviewed the tenders for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, TAG Construction Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 30 working days. TAG's past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. We, therefore, recommend that TAG Construction Ltd. be awarded the work.

## FUNDING

Funding, in addition to the contribution from the adjacent developer, is available within the approved Engineering budget.
