### RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1707-008 to Aggressive Roadbuilders Ltd. in the amount of \$1,371,051.44, including GST; and
- 2. Set the expenditure authorization for Contract M.S. 1707-008 at \$1,467,000, including GST.

# **SCOPE OF WORK**

Contract M.S. 1707-008 involves sidewalk construction to address current priorities, cul-de-sac construction in conjunction with the Parks Department's upgrading of Holland Park and an eastbound left turn lane on 100 Avenue at 156 Street to address traffic operations concerns. #### **EVALUATION**

Our consultant reviewed the tenders for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Aggressive Roadbuilders Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 75 working days as stipulated in the contract. Aggressive's past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. We, therefore, recommend that Aggressive Roadbuilders Ltd. be awarded the work.
