RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract MS 1707-010-11 to Imperial Paving Ltd. in the amount of \$2,418,798.10 including 6% GST.
- 2. Set the expenditure authorization for Contract MS 1707-010-11 at \$2,540,000.00 including 6% GST.

TENDER RESULTS

Tenders for Contract M.S. 1707-010-11 were received on July 10, 2007, with the results as follows:

EVALUATION

Our consultant reviewed the tenders for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Imperial Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and offered to complete the work within 75 working days, which is less than the 80 days stipulated in the contract. Imperial's past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. We therefore recommend that Imperial Paving Ltd. be awarded the work.

FUNDING

Funding is available within the approved Engineering budget. The project on 32 Avenue between 176 Street and 184 Street is primarily funded by a gravel haul levy collected from the Province as a result of their pit operation on 32 Avenue. The project on 95 Avenue, west of 192 Street is fully funded by TransLink as part of the Golden Ears Bridge approach works.
