#### **EVALUATION**

Our consultant reviewed the tenders for accuracy and completeness. A tender was received from Double M Excavating Ltd.; however, it was rejected due to non-compliance with the tender submission documents process. No errors were found in the accepted tenders. All accepted submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Aggressive Roadbuilders Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 120 working days as stipulated in the contract. Aggressive's past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. We, therefore, recommend that Aggressive Roadbuilders Ltd. be awarded the work.
