SUBJECT: Additional Appointment to the Advisory Design Panel

#### RECOMMENDATIONS

The Planning and Development Department recommends that Council appoint Ron Myers, BCSLA, to the Advisory Design Panel (the "ADP") for a term expiring on January 1, 2010.

#### **BACKGROUND**

On October 22, 2007, Council received Corporate Report No. R225, which recommended appointments and renewals for persons to the ADP and revisions to the ADP Terms of Reference. At that time, there were a number of vacant positions yet to be filled or appointed, including one Landscape Architect position. This purpose of this report is to request Council's authorization to fill the vacant Landscape Architect position. A list of ADP members and vacancies is attached as Appendix "A".

#### **DISCUSSION**

## **Landscape Architect Candidate**

The nomination of Landscape Architects to municipal advisory design panels must be approved by the BC Society of Landscape Architects (BCSLA). The BCSLA approval of the proposed panel member, Ron Myers, was received after Corporate Report No. R255 was submitted to Council. The proposed term for the new ADP member has been reviewed with the BCSLA and generally complies with the policy set out in the City of Surrey ADP Terms of Reference.

Ron Myers is a member of the BC Society of Landscape Architects (BCSLA) and is currently Deputy Director, Parks Recreation & Culture for the Corporation of Delta. He has approximately 20 years of experience as a landscape architect in the municipal planning sector and private practice, and extensive experience with both planning policy and landscape design issues and with a variety of project types (see Appendix "B").

#### **CONCLUSION**

It is recommended that Council appoint Ron Myers, BCSLA, to the ADP for a term expiring on January 1, 2010.

## Biographical Information for Ron Myers, BCSLA

Ron Myers graduated from the UBC School of Landscape Architecture in 1988 and is currently Deputy Director, Parks Recreation & Culture for the Corporation of Delta. Ron is also a Certified Arborist.

In the public sector, the bulk of Ron's work has been park design and planning, tree retention, and DP review with related planning issues. He has participated in a significant number of development permit application reviews and approvals with both the District of North Vancouver and Abbotsford. He has also worked on neighbourhood design guidelines for municipal subdivisions for the District of North Vancouver. This included streetscape design and requirements, neighbourhood design guidelines, DCC credits for parkland, tree retention, and park allocations. In this role he also conducted post development inspections and approvals.

Ron has also worked in private practice for Chris Phillips and Associates (now Phillips Farvaag & Smallenberg Landscape Architects) and LA West Landscape Architects. His private practice work has included projects in Vancouver, West Vancouver and New Westminster and a variety of project types including multi unit residential (both medium and high density), commercial, and congregate care type facilities.
