The low bidder, Aggressive Roadbuilders Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 60 working days as stipulated in the contract. Their past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. We, therefore, recommend that Aggressive Roadbuilders Ltd. be awarded the work.
