SUBJECT: Cultural Capitals of Canada Civic Treasures Award Program

## RECOMMENDATION

The Parks, Recreation and Culture Department recommends that Council:

- 1. Receive this report for information and;
- 2. Approve the implementation of the Civic Treasures Award program as documented in this report.

#### **BACKGROUND**

In March 2006, the City of Surrey submitted a bid proposal to the Department of Canadian Heritage to compete for a Cultural Capital of Canada designation for 2008. The proposal contained 8 innovative and significant cultural projects including one entitled "Civic Treasures Award Program".

In June 2007, Surrey was awarded the Cultural Capital of Canada designation for 2008. The Mayor appointed a Council Committee to oversee the program. The Committee includes the Mayor along with Councillor Villeneuve, Councillor Martin and Councillor Hepner. Community members and staff are involved in the planning and delivery of each of the eight unique projects.

A community based Steering Committee was formed to work on the development of the "Civic Treasures Award" program. (See APPENDIX A: Civic Treasures Community Steering Committee- Members' List) The Committee has completed the following work:

- Clarified the purpose of the award program,
- Outlined the nomination process,
- Developed selection criteria for the award recipients,
- Reviewed the budget,
- Conducted "best practises" research,
- · Identified outreach and promotional opportunities,
- Generated a list of potential award presentation venues/events,
- Reviewed a draft artists call to generate a design for the award,
- Created a program timeline, and
- Drafted a proposed program for Council consideration.

#### **DISCUSSION**

There have been on-going discussions in the community regarding a cultural awards program since 2002 when Surrey hosted the BC Festival of the Arts. Out of these discussions came the proposal for a "Civic Treasures Award"; the Cultural Capitals of Canada program has provided an opportunity to launch this legacy project.

In Surrey's Cultural Strategic Plan (CSP) strategic direction #1 states that "Community leadership and a strong commitment to the ownership of Surrey's cultural services and resources must be active, facilitated and supported; "culture" is the term used to encompass the arts, cultural industries, heritage, libraries and multi-culturalism. The Steering Committee confirmed this inclusive definition and proposes to recognize individuals for their significant achievements in one or a combination of these professional fields.

# Purpose of the Award

The Committee has confirmed the following as being the purpose of the award program:

- Provide a high level of acknowledgement for the recipients and their contribution to the cultural sector in Surrey.
- Provide a positive profile for the City of Surrey in relation to advancing cultural development.
- Become a sustainable legacy created through the 2008 Cultural Capitals of Canada award.
- Be an instrument to recognize and celebrate Surrey's highest achievers in the cultural
- sector providing positive role models for the emerging cultural leaders in the community.
- Generate greater awareness, interest and support for arts and culture in Surrey.
- Demonstrate that Surrey values the arts and those people who dedicate their lives to this field.
- Profile Surrey as a creative cultural centre and encourage tourism.
- Promote cross cultural sharing and build awareness, understanding and community pride.

In this first year of the program up to 12 award recipients may be selected and the awards will be presented at an appropriate Cultural Capitals of Canada event or other existing event. (See APPENDIX C: Sample of Potential Presentation Venues) This is intended to be a legacy project and in future years, awards will be presented at appropriate events, such as, for example, the annual Surrey Arts Centre - Surrey Board of Trade Business and the Arts reception.

# Best Practises Research

The Committee reviewed internal City programs such as the Friends of Heritage awards, local programs such as the Leader newspapers Community Leader Awards and cultural award programs in other cities. The Youth Arts Council of Surrey, the Surrey Festival of Dance Society and other organizations are currently providing various scholarships and awards to emerging youth artists and the committee felt that this was adequate recognition.

The City of Vancouver recently completed a review of their awards programs. Conducted by Janzen and Associates, the report included information regarding programs in Seattle, Calgary, Edmonton and Toronto. In addition, the report included information from the Creative City Network of Canada where similar research was conducted in 22 Canadian cities. (See APPENDIX B: Best Practises Research - Summary) Although a number of awards programs included a cash prize component supported through business sponsorships, the research indicated that this was difficult to sustain. The Steering Committee concluded that there were many ways to recognize and award recipients and attribute value to being selected a Civic Treasure without a cash prize component.

A commemorative medallion will be created to present to the award recipients and the Steering Committee will continue to explore additional ways to promote the award winners and their contributions to Surrey's cultural development.

## **Nomination Criteria**

The Committee recommended that nominees be Surrey residents, born in Surrey or have a strong connection to the City of Surrey. Their accomplishments should:

- Demonstrate excellence and contribute significantly to the appreciation and development of culture in Surrey.
- Reflect the unique character and history of the City.
- Represent a significant achievement in the arts, heritage or cultural industries or promotion of multi-culturalism.

#### **Selection Process**

The Committee proposes to implement an extensive community outreach process to create awareness of the awards program and generate nominations. A non-voting City staff person will facilitate the work of a jury of peers consisting of 3 to 5 members to review the nominations and complete the selection process. A summary of the finalists with the jury's recommendations will be forwarded to Council for final approval.

#### **SUMMARY**

Since 2002, the community in Surrey has discussed the need to recognize individuals who are considered cultural leaders and positive role models. The Civic Treasures Award project, part of the Cultural Capitals of Canada Award, will allow this to occur.

Surrey's Cultural Strategic Plan's direction that "Community leadership and a strong commitment to the ownership of Surrey's cultural services and resources must be active, facilitated and supported" is consistent with research completed in other cities. For example, the Janzen & Associates City of Vancouver Awards review concluded, "that awards are a vital, important aspect of meeting City and cultural objectives."

The Civic Treasures Award is intended to be a legacy award that will emphasize the value that the City of Surrey places on its cultural leaders.

The Civic Treasures Community Steering Committee recommend establishing a sustainable awards program that will bring distinction to Surrey and advance cultural development in the City.
