RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1708-005-11 to Winvan Paving Ltd. in the amount of \$1,599,558.71 (including 5% GST); and
- 2. Set the expenditure authorization for Contract M.S. 1708-005-11 at \$1,730,000.00 (including 5% GST).

TENDER RESULTS

Tenders for Contract M.S. 1708-005-11 were received up to May 27, 2008, with the results as follows:

The Engineer's pre-tender estimate was \$1,596,000 (including 5% GST).

EVALUATION

The City's consultant reviewed the tenders for accuracy and completeness. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Winvan Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 50 working days as stipulated in the contract. Winvan's past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. We, therefore, recommend that Winvan Paving Ltd. be awarded Contract M.S. 1708-005-11.

FUNDING

Funding is available within the approved Engineering budget derived through the Local Roads and Traffic Safety levy. This contract is the first significant work being funded under the new levy and is the largest contract ever awarded for local road paving in the City, with 20 locations being included. An extensive local road crack-sealing program is also being developed for implementation this summer with an award of the related contract to be forwarded to Council for approval shortly.
