RECOMMENDATIONS

The Engineering Department recommends that Council:

1. Award Contract M.S. 4708-001-11 to TAG Construction Ltd. in the amount of \$742,140.00, including GST; and
2. Set expenditure authorization for Contract M.S. 4708-001-11 at \$850,000.00 including GST.

SCOPE OF WORK

This construction package consists of sanitary sewer and water main works at the following locations:

Type of Work	Project	Location
Sewer	4707-602	100 Avenue: 13840 to 13981
	4707-603	Grosvenor Road: Melrose Drive to 14165
	4708-310	Bentley Road: KG Hwy. to Binnie Lane
Water	1207-357	112 Avenue: 129 Street to 131 Street

These works involve either twinning or replacing existing sections of sanitary sewer and water main to meet expected demand due to new development. The work is expected to start in August 2008 and be completed by October 2008.

TENDER RESULTS

Tenders for the above contract were received on June 26, 2008 as follows:

The Engineer's pre-tender estimate was \$930,000.00 including GST.

EVALUATION

The City's consultant reviewed the tenders for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, TAG Construction Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 45 working days, as stipulated in the contract. TAG Construction Ltd.'s past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. It is recommended that TAG Construction Ltd. be awarded Contract number M.S. 4708-001-11.

FUNDING

Funding for this contract is available in the approved 2008 Budget.
