Construction of Sidewalks and Raised Medians

RECOMMENDATION

The Engineering Department recommends that Council:

1. Award Contract M.S. 1708-011-11 to Double M Excavating Ltd. in the amount of \$1,135,966.55, including GST; and
2. Set the expenditure authorization for this Contract at \$1,205,000.00, including GST.

SCOPE OF WORK

Contract M.S. 1708-011-11 includes the following projects:

These works include the construction of sidewalks at various locations throughout the City and the construction of raised medians on 16 Avenue and 128 Street in the commercial area of Ocean Park. The medians are being installed at the request of the Ocean Park Community Association and have been the subject of extensive community and local business consultation, with broad general support. The Transportation Committee of Council reviewed the plan for the installation of the raised medians as

provided in this Contract at its meeting on May 5, 2008. The Committee supported the work as proposed.

The work of the Contract is expected to start on September 22 and be completed by December 3, 2008.

TENDER RESULTS

Tenders for the subject Contract were received on August 26, 2008, as follows:

The Engineer's pre-tender estimate was \$1,137,470.25 including GST.

EVALUATION

The City's consultant reviewed the tenders for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Double M Excavating Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 50 working days as stipulated in the contract. Double M Excavating Ltd.'s past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. On this basis, it is recommended that Double M Excavating Ltd. be awarded Contract M.S. 1708-011-11.

FUNDING

Funding for this contract is available in the approved 2008 Capital Budget.
