## RECOMMENDATION

Legal Services recommends that Council:

1. Approve amendments to the fines prescribed in Surrey Municipal Ticket Information Utilization By-law, 1994, No. 12508 (the "MTI By-law") as documented in Appendix "A" to this report;
2. Approve consequential amendments to the fines prescribed in other regulatory by-laws as documented in Appendix "B" to this report; and
3. Instruct the City Clerk to introduce the appropriate amending by-laws.

## BACKGROUND

A complete review was conducted of the MTI By-law as it related to the prescribed fine amounts for various regulatory by-laws enacted by Council. Previously, under the *Municipal Act* any amendments to fine amounts or adjustments to fines had to be approved by the Office of the Chief Judge of the Provincial Court. This requirement has been removed with the enactment of the *Community Charter*, S.B.C. 2003, c. 26 (the "*Community Charter*"). Furthermore, under the *Community Charter*, the maximum fine amount permitted under an MTI By-law has been raised from \$500.00 to \$1,000.00.

## DISCUSSION

A review of the fine amounts prescribed within the MTI By-law revealed that many of the prescribed fine amounts are lower than the cost to purchase the required permit or license. It also revealed that a number of fines were not indicative of the severity of the offence involved, such as the infraction "Dangerous Dog Not Confined". Similarly, many of the current fines did not cover the administrative costs involved in processing the tickets. Each of Appendices "A" and "B" list the proposed new fine amount for each offence with the current fine as a comparison. Where no "current fine" is displayed, the offence is either new or has been added as an offence to the MTI By-law to allow for an alternative to prosecution by long form charge preparation. There are a number of common offences that have been added for which MTI tickets could not have been previously written.

The recommended fine amounts are consistent with the fine amounts that were put in place with the enactment of the City's newer regulatory by-laws, such as the Surrey Tree Protection By-law, 2006, No. 16100, Surrey Soil Conservation and Protection By-law, 2007, No. 16389 and the Erosion and Sediment Control By-law, 2006, No. 16138.

Staff also identified a few gaps in the ticket offences. New fines have been included in cases where new zones have been added to the Zoning By-law without having been reflected in the MTI By-law. There are also several new provisions in the underlying regulatory by-laws that have been added as offences to the MTI By-law along with related fines. For example, the Surrey Fire Services By-law (Appendix "A", p. 10) now makes the failure to submit a fire safety plan an offence. These new offences and fines can be identified in Appendix "A" (pages 1 – 7 and page 10) where there is no "current fine" shown on the Appendix.

There are also a number of City regulatory by-laws that were enacted between 1969 and 1980, which have fine provisions that are out of date and not reflective of the City's current fine provisions. For example, in the Regulation of Garbage Disposal By-law, 1971, No. 3495, the maximum fine amount prescribed by the by-law is \$100.00. Most of the City's regulatory by-laws now have maximum fines of either \$2,000.00 or \$10,000.00. Such maximum fines are not recognized through the MTI ticketing process, but are rather put in place for infractions that are taken forward to the Courts in the form of long form charges.

It is noted that the proposed fines are consistent with fines that have been prescribed by other local governments in the lower mainland.

## CONCLUSION

Based on the above, Legal Services recommends that Council:

- Approve amendments to the fines prescribed in Surrey Municipal Ticket Information Utilization By-law, 1994, No. 12508 (the "MTI By-law") as documented in Appendix "A" to this report;
- Approve consequential amendments to the fines prescribed in other regulatory by-laws, as documented in Appendix "B" to this report; and
- Instruct the City Clerk to introduce the appropriate amending by-laws.

Any person who violates any provision of this By-law shall be guilty of an offence against this By-law and shall be liable on summary conviction, to a fine of not exceeding One Hundred Dollars (\$100.00) and in default of payment thereof forthwith to imprisonment in the common goal for any period not exceeding thirty (30) days unless the said fine or penalty and costs, if any, be sooner paid. For each day that a violation is permitted to exist, it shall constitute a separate offence.
