**RECOMMENDATIONS**

The Engineering Department recommends that Council:

1. Award Contract M.S. 1209-004-21 to Double M Excavating Ltd. in the amount of \$3,369,728.17, including GST; and
2. Set the expenditure authorization for Contract M.S. 1209-004-21 at \$3,570,000.00, including GST and contingency.

**SCOPE OF WORK**

This contract involves upgrading of the water feeder main network in the vicinity of the Kennedy Pump Station including upsizing and twinning of the transmission mains from the pump station. This project, upon completion, will improve water pressure within the Kennedy area significantly.

This construction package consists of four projects as follows:

This work is expected to start in June 2009 and be completed by late November 2009.

## TENDER RESULTS

Tenders for the subject contract were opened on May 20, 2009, and were as follows:

The Engineer's pre-tender estimate was \$4,071,585.00 including GST.

## EVALUATION

The City's consultant reviewed the tenders for accuracy and completeness. There were adjustments for arithmetic errors, but these did not alter the outcome of the tender. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Double M Excavating Ltd., has submitted a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 75 working days, as stipulated in the Contract. Double M Excavating Ltd.'s past work performance with the City has been very satisfactory. They have no outstanding legal claims against the City.

It is recommended that Double M Excavating Ltd. be awarded Contract M.S. 1209-004-21.

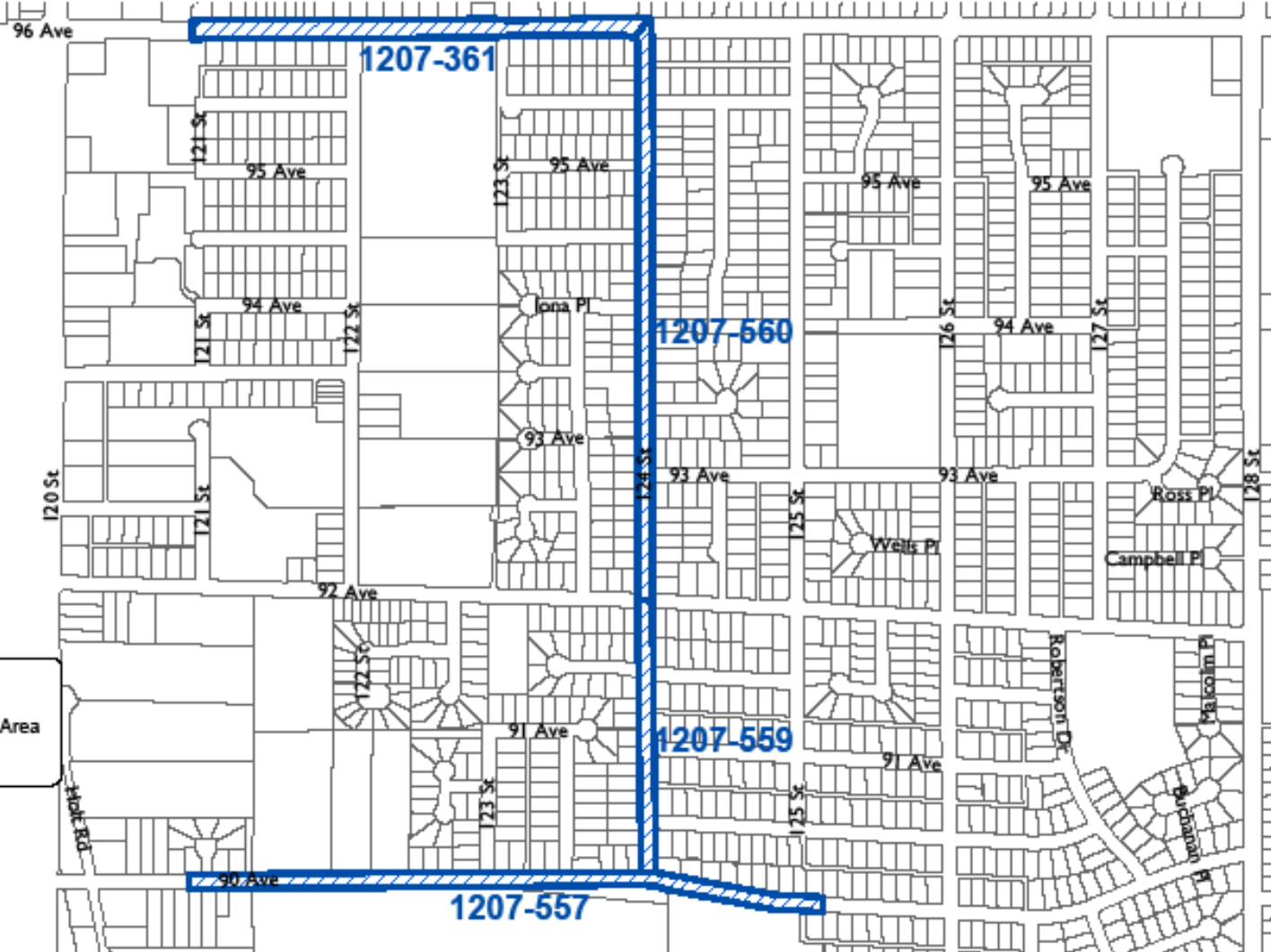
Funding for this contract is available in the approved 2009 Budget.
