32 Avenue Widening between 160 Street and 168 Street

RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1705-012-21 to B & B Contracting Ltd. in the amount of \$4,884,600, including GST; and
- 2. Set the expenditure authorization limit for Contract M.S. 1705-012-21 at \$5,373,000 including GST and contingency.

SCOPE OF WORK

Contract M.S. 1705-012-21 relates to the widening 32 Avenue between 160 Street and 168 Street. The existing two lane road will be widened on the north side to include a painted centre median, bicycle lanes, pedestrian sidewalk, street lights and intersection improvements at 168 Street. The section of 32 Avenue that will be widened is shown on the map attached as Appendix I.

The work is expected to commence in July 2009 and be completed by the end of October 2009.

TENDER RESULTS

Tenders for the subject contract were opened on June 9, 2009 with the following results:

The Engineer's pre-tender estimate was \$5,500,000 including GST.

EVALUATION

The City's consultant reviewed the tenders for accuracy and completeness. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices. There was one minor arithmetic error that had no bearing on the outcome of the tender process.

The low bidder, B & B Contracting Ltd., has submitted a Consent of Surety for a Performance Bond and a Labour & Materials Bond and agreed to complete the work within 60 working days, as stipulated in the Contract. B & B Contracting Ltd.'s past performance has been satisfactory. They have no outstanding legal claims against the City. It is recommended that B & B Contracting Ltd. be awarded Contract M.S. 1705-012-21.

FUNDING


Funding for this contract is available in the approved 2009 Budget.
