Surrey City Centre - 104 Avenue Storm Sewer

#### RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 4809-003-11 to Mainland Civil Works Inc. in the amount of \$802,142.25, including GST; and
- 2. Set the expenditure authorization limit for Contract M.S. 4809-003-11 at \$885,000.00, including GST.

## **SCOPE OF WORK**

The construction package covered by the subject contract includes the installation of approximately 1.0 km of large diameter storm sewer to facilitate future development in the Surrey City Centre. More specifically, the sewer will be constructed on 104 Avenue, between 132 Street and West Whalley Ring Road. The new storm sewer will support the objectives of the City of Surrey Economic Investment Action Plan and, specifically, the City Centre Economic Zone.

The work is expected to start July 13, 2009 and be completed by October 12, 2009.

## **TENDER RESULTS**

The Engineer's pre-tender estimate was \$1,421,000.00 including GST.

## **EVALUATION**

The City's consultant reviewed the tenders for accuracy and completeness. Minor mathematical errors were found that did not affect the outcome of the tender process. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Mainland Civil Works Inc., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond and agreed to complete the work within 60 working days as stipulated in the contract. Mainland Civil Works Inc.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Mainland Civil Works Inc. be awarded Contract M.S. 4809-003-11.


### **FUNDING**
