Miscellaneous Road Works and Bicycle Pathways

RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1709-010-11 to Double M Excavating Ltd. in the amount of \$1,747,749.08, including GST; and
- 2. Set the expenditure authorization limit for Contract M.S. 1709-010-11 at \$1,920,000.00, including contingency and GST.

SCOPE OF WORK

This construction package covered under this Contract includes minor road projects and off street bicycle pathway at the locations listed in the following table. A map that illustrates the referenced locations is attached as Appendix I.

The work is expected to commence on July 13, 2009, and be completed by December 3, 2009.

Tenders for the subject contract were opened on June 11, 2009 with the following results:

The Engineer's pre-tender estimate was \$2,500,000, including GST.

EVALUATION

The City's consultant reviewed the tenders for accuracy and completeness. All submissions included the required 10% bid bond and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Double M Excavating Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 100 working days, as stipulated in the contract. Double M Excavating Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Double M Excavating Ltd. be awarded Contract M.S. 1709-010-11.


FUNDING

Funding for the roads component of this contract is available within the 2009 Budget. Funding in the amount of \$1,280,000 for the Bicycle Pathways is available from the B.C. Build Canada Infrastructure Program (2/3 share) and the remaining \$640,000 (1/3 share) is available in the approved 2009 budget. This is the first significant bicycle pathway contract being funded under the B.C. Build Canada Infrastructure program. Two additional pathway contracts are being developed for implementation later this summer and early next spring.
