Non-Arterial Road Paving and Pavement Patching at Various Locations

### RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1710-002-11 for non-arterial road paving and pavement patching at various locations throughout the City to Quality Paving Ltd. in the amount of \$1,525,932.35 including GST/HST; and
- 2. Set the expenditure authorization limit for Contract M.S. 1710-002-11 at \$1,796,000.00 including contingency and GST/HST.

## **SCOPE OF WORK**

The construction package related to this Contract consists of road paving and patching at the locations listed in the following table and illustrated on the map attached as Appendix I.

The Contract work is expected to start April 26, 2010, and be completed by August 11, 2010.

The Engineer's pre-tender estimate was \$1,745,000 including GST.

#### **EVALUATION**

The City's consultant reviewed the tenders for accuracy and completeness. There was one arithmetic error that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Quality Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond and agreed to complete the work within 75 working days as stipulated in the contract. Quality Paving Ltd. has not worked for the City in the past. Consequently, they were asked to provide additional information regarding their references and previous experience, both of which proved satisfactory. Staff and our consultant also carried out an inspection of their asphalt plant and paving equipment. A review was conducted of Quality Paving Ltd.'s subcontractors who were found to have satisfactory post performance on capital roadway projects. Quality Paving Ltd. also has an agreement to purchase asphalt mix locally for the same unit price should logistic difficulties arise due to Highway #1 upgrade conflicts with transporting mix from their plant in Chilliwack. They have no outstanding legal claims against the City.

It is recommended that Quality Paving Ltd. be awarded Contract M.S. 1710-002-11.

#### **SUSTAINABILITY CONSIDERATIONS**

The proposed road improvements will prolong the life of the existing road structure as well as provide smoother and quieter travel for both vehicles and cyclist movement along these non-arterial roads, supporting the Sustainability Charter's vision of efficiently moving people and goods, not just vehicles. The project will enhance the public realm by implementing street standards that minimize the negative impacts of transportation facilities on communities, while providing appropriate infrastructure in support of the City's transportation needs. In particular, the project supports the Charter Scope actions related to:

- SC 13: Creating a Fully Accessible City
- EN 13: Enhancing the Public Realm

In addition to the improved level of service that this contract will provide to road users, the project will also assist in achieving the objectives in the City's Economic Investment Action Plan related to stimulating the local economy and creating local jobs through capital investment by the City.

#### **FUNDING**


Funding for this contract is available in the approved 2010 Budget.
