SUBJECT: Local Area Service - Water Main Extension on 84 Avenue from 188 Street to

192 Street and on 188 Street from 84 Avenue to the 8500 Block

#### RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Approve the establishment of a Local Area Service (LAS) to allow a water main extension along 84 Avenue between 188 Street and 192 Street and along 188 Street between 84 Avenue and the 8500 Block at an estimated total cost of \$303,000, which costs will be fully recovered by a local service tax and will be apportioned based on final costs on a frontage basis across the benefitting properties in accordance with City policy; and
- 2. Authorize the City Clerk to bring forward the necessary LAS By-law for the required readings.

#### **INTENT**

The purpose of this report is to advise Council of a petition that has been received by the City for a water main extension as a Local Area Service, which has been deemed 'sufficient' to proceed to construction.

#### **DISCUSSION**

The owners of properties fronting 84 Avenue between 188 Street and 192 Street and fronting 188 Street between 84 Avenue and the 8500 Block (as illustrated on the map attached as Appendix I) have petitioned the City to extend a water main to service each of these properties. The petition has been certified to be 'sufficient' in accordance with the *Community Charter*. A copy of the City Clerk's Certificate of Sufficiency is attached as Appendix II.

The costs of the water main extension have been estimated at \$303,000.00 and will be shared between the properties within the benefiting area based on the frontage of each property in accordance with the City's LAS Policy as documented in the Engineer's Report, which is attached as Appendix III.

Funding for the water main extension is available in the approved Water Capital LAS Program.

#### SUSTAINABILITY CHARTER/CONSIDERATIONS

This project will supply water to agricultural lands for both domestic and limited agricultural use such as crop washing, and therefore will support local food production. The new water main will be installed by horizontal directional drilling, a trenchless technology which generates lower CO<sub>2</sub> as compared to traditional open cut construction methods.

The project supports the following Sustainability Charter Scope actions:

- SC14: Support Local Food Production; and
- EN1: Reduce Green House Gases.

#### **CONCLUSION**

Based on the above discussion, it is recommended that Council:

- Approve the establishment of a Local Area Service (LAS) to allow a water main extension along 84 Avenue between 188 Street and 192 Street and along 188 Street between 84 Avenue and the 8500 Block at an estimated total cost of \$303,000, which costs will be fully recovered by a local service tax and will be apportioned based on final costs on a frontage basis across the benefitting properties in accordance with City policy; and
- Authorize the City Clerk to bring forward the necessary LAS By-law for the required readings.



Location: Water Main Extension on 84 Avenue between 188 Street and 192 Street and on 188 Street from 84 Avenue to 8500 Block, as shown in the Appendix I.

Estimated Service connection Cost per property \$2,900

Total Frontage of the Properties in the Local Service Area 1,473.06 m

Cost Per Linear Metre for the LAS Cost Share \$175.66

Amortization Period 15 years
