**Annual Road Restoration Services**

## RECOMMENDATION

The Engineering Department recommends that Council:

1. Award Contract 1220-40-54-10 involving the provision of road restoration services to Grandview Blacktop Limited in the amount of \$525, 000, including HST; and
2. Set the expenditure authorization limit for Contract 1220-40-54-10 at \$577,500, including HST.

## SCOPE OF WORK

The scope of work related to this contract includes the supply and delivery of labour and material for minor road restoration works throughout the City. The City does not have sufficient internal resources to undertake this type of work. The following list provides a brief description of the primary elements of work under this contract:

- Hot-Mix Pavement Patching (Permanent)
- Pavement Patching (interim / temporary)
- Concrete and Asphalt Sidewalk Construction
- Asphalt and Concrete Curb Replacement

The City has an option to extend the contract for two (2) additional twelve (12) month periods at the same unit rates. It is anticipated that extending the contract for the additional 2 years will result in additional savings to the City. This will be fully evaluated at the end of each 12 month term and a recommendation made at that time.

## QUOTATION RESULTS

Quotations for the subject contract were received on August 11, 2010, with the following results:

2. Blackrete Contracting Ltd.	\$672,380
3. Keywest Asphalt Ltd.	\$713,950
4. Winvan Paving Ltd. Chet Construction Ltd.	\$714,454
5. Lafarge Canada Inc. (Columbia Bithulithic)	\$1,735,682

All of the above estimated amounts include HST. The City's pre-quotation estimate was \$520,000 including HST.

## EVALUATION

The quantities of the work for this contract are best estimates. Grandview Blacktop Ltd. submitted the lowest quotation and meets all the requirements and specifications of the quotation. Grandview Blacktop Ltd. has provided the City with similar services in the past and their work has been satisfactory. Based on their quotation submission, previous experience, knowledge of the work and reliability as demonstrated through previous contracts, it is recommended that the subject contract be awarded to Grandview Blacktop Ltd.

## SUSTAINABILITY CONSIDERATIONS

The proposed road restoration work will assist in achieving the objectives of the City's Sustainability Charter. In particular, the work supports the Charter Scope actions related to:

- EC<sub>3</sub>: Sustainable Infrastructure Maintenance and Replacement
- EN 13; Enhancing the Public Realm

Funding for this contract is available in the approved 2010 Budget.
