SUBJECT: Award of Contract for Construction of a Covered Youth Park in Tom Binnie

Park

#### RECOMMENDATION

The Parks, Recreation and Culture Department recommends that Council award Contract No.1220-30-34-10 for the construction of a covered youth park in Tom Binnie Park to New Line Skate Parks Inc. in the amount of \$1,346,984.73 plus HST.

#### INTENT

The purpose of this report is to obtain Council authority to award a contract to New Line Skate Parks Inc for the construction of the a youth park in Tom Binnie Park.

## **BACKGROUND**

At a Regular meeting in May 2009, Council adopted the recommendations of Corporate Report Ro90 (a copy of that report is attached as Appendix 1), which included the approval of funding for the construction of a Youth Park in Tom Binnie Park. The Corporate Report addressed several projects that were to be jointly funded through the *Recreational Infrastructure Canada* (RInC) Program. The Federal Government has provided a commitment of \$486,585 toward the subject Youth Park project, with the balance to be funded by the City.

The youth park project includes construction of a covered skate park, a ball-hockey court, pathways, rain gardens and other associated works.

## **DISCUSSION**

The City issued a Request for Proposals for this project in September 2010. Four proposals were received, which were reviewed by an evaluation committee that included a representative from the Purchasing and Payments Section, the Manager of Parks Development Services and the Landscape Architect for the project. The projects were evaluated in the following areas:

- Price:
- Experience of Proponent in delivering this type of project; and
- Technical aspects of the proposal.

Each of the following companies submitted a proposal:

- New Line Skate Parks Inc.
- PCL Constructors Westcoast Inc.
- Wilco Landscape Westcoast Inc.
- Interpave Precast Systems Ltd.

The evaluation of the proposals concluded that the proposal from New Line Skate Parks Inc. offered the best value to the City. The New Line Skate Parks Inc. proposal also contained the lowest price.

New Line Skate Parks Inc. has successfully completed three youth parks in the City of Surrey and has an excellent track record of constructing youth parks throughout North America.

## **Schedule for Project Construction**

Construction on the project is expected to commence in November 2010 and be completed by April 2011.

## **Project Funding**

Funding for this contract is available within the approved 2010 Capital budget, which includes the above-referenced RInC funding that has been committed to the project by the federal government.

#### **SUSTAINABILITY CONSIDERATIONS**

The project will assist in achieving the goals of the Surrey Sustainability Charter in a variety of ways. The project includes planted bio-swales that will clean storm water prior to the water entering the City's storm system. The project's lighting system has been designed to be energy efficient. The facility will be constructed in a manner that preserves and protects most of the existing trees on the site. The facility will provide accessible and affordable recreation opportunities for youth.

#### **CONCLUSION**

Based on the above discussion, it is recommended that Council authorize staff to award the contract for the construction of the youth park to New Line Skate Parks Inc in the amount of \$1,346,984.73 plus HST.

### RECOMMENDATION

The Parks, Recreation & Culture Department recommends that Council:

- 1. Receive this report as information; and
- Approve the submission of the following projects, that are described in more detail in this report and in the priority in which they are listed, for funding under the Recreational Infrastructure Canada (RInC) Program:
  - a) Hjorth Road Park Artificial Turf Field
  - b) Kensington Prairie Community Centre South Surrey
  - c) Arena Renovations North Surrey
  - d) Newton Fitness Centre/Programming Rooms
  - e) Kwomais Point Park South Surrey
  - f) Tennis Court Renovations Cloverdale
  - Newton Athletic Park Replacement & Upgrading of Gravel Field to New Artificial Turf Field
  - h) Cloverdale Arena and Curling Rink Renovation
  - i) City Centre Games Preparation Centre Covered Youth Park; and
- Direct staff to pursue funding for the subject projects from the Provincial Government and others to supplement the funding that is made available from the RInC Program.

## BACKGROUND

The 2009 Federal budget announced \$12 billion in new and accelerated infrastructure funding through a new Canada Economic Action Plan. The funding is to be used over the next two years. From this new funding, \$500 million has been identified to support the Recreational Infrastructure Fund (RInC) Program.

#### DISCUSSION

The Recreational Infrastructure Canada (RInC) Program provides funding to rehabilitate recreational facilities across Canada subject to such projects being completed by March 31, 2011. Under the Program criteria, projects that can start quickly will receive preference over others.

The RinC Program is targeted at upgrades and repairs to existing recreational assets such as arenas, gymnasiums, swimming pools, sports fields, sport courts, parks, fitness and bike paths and other multi-purpose physical recreation facilities.

The Program is designed to provide a timely, targeted stimulus to the economy, and to help mitigate the impacts of the global economic recession by increasing the total amount of construction activity related to recreational infrastructure. Through the rehabilitation of recreational infrastructure, this Program also encourages participation in physical activity and community building.

The initial RinC funding allocation for Western Canada, to be delivered by Western Economic Diversification Canada, amounts to about \$54 million. The remaining funding, over the next two years, will be allocated based on the number of applications submitted to the WED. Projects will be selected by WED on the basis of merit and construction readiness.

The Program funds up to 33 per cent of the costs of selected projects. The remaining funding will need to be sourced internally by the City or it may be possible to achieve some level of funding from the provincial government, community organizations, or the private sector. The maximum federal contribution to any one project under this Program is \$1 million.

Under the Program, projects for which applications for funding are received will be assessed on:

- · construction-readiness;
- planned completion date;
- · incrementality; and
- the extent to which other funding is leveraged.

The Parks, Recreation and Culture Department has undertaken a careful assessment of possible projects that could be submitted for funding under this Program. The projects that have been chosen as listed below are consistent with the recommendations of the Parks, Recreation and Culture Ten-Year Strategic Plan. They are listed in order of the priority.

This project will replace a gravel all-weather field and with a state of the art infill artificial turf field that will be lighted for night time use. 9.		at entrance, landscape & fencing.  This project involves the construction of a youth facility that is a flat surface of approximately 20 m x 40 m, with a full roof. The sides of the facility have roll-up garage style doors that can be closed at night or during very cold weather. The facility contains locked storage areas. The open floor area may be configured for ball hockey, basketball, or other court games. In addition, portable ramps and jumps may be put into place to facilitate skateboarding and bmx biking. The facility is attached on one side to the recreation centre, to take advantage of public restrooms and other over-flow programming space.	\$3 M

- i) City Centre Games Preparation Centre Covered Youth Park
