**Construction of Sanitary Sewers** 

### RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 4711-003-11 for the construction of sanitary sewer mains to Pedre Contractors Ltd. in the amount of \$1,084,045.20 including HST; and
- 2. Set the expenditure authorization limit for Contract M.S. 4711-003-11 at \$1,200,000.00 including contingency and HST.

#### **SCOPE OF WORK**

The construction package related to this contract consists of construction of sanitary sewer mains at various locations as listed in the following table and illustrated on the map attached as Appendix I.

The work is expected to commence in early October 2011 and be completed by April 2012.

#### **TENDER RESULTS**

Tenders for the subject contract were received on August 19, 2011, with the following results:

Contractor	Tendered Amount with HST	Corrected Amount
1. Pedre Contractors Ltd.	\$1,084,045.20	No Change
2. S. McKay Contracting Ltd.	\$1,218,333.87	No Change

The Engineer's pre-tender estimate was \$1.15 million including HST.

#### **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. Both submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Pedre Contractors Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and has agreed to complete the work within the timeframe stipulated in the tender documents. Pedre Contractors Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Pedre Contractors Ltd. be awarded Contract M.S.4711-003-11.

#### **SUSTAINABILITY CONSIDERATIONS**

The utility upgrading works that will be constructed under this contract will minimize life cycle operational and maintenance costs. This is consistent with action item EC<sub>3</sub> of the City's Sustainability Charter "Sustainable Infrastructure Maintenance and Replacement", which stipulates that the City will recognize full life cycle costing in infrastructure decisions.


Funding for this Contract is available in the approved 2011 Capital Budget.
