#### RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1711-015-11 to Winvan Paving Ltd. for the construction of Transit and Road-Related Minor improvements at various locations throughout the City in the amount of \$1,090,412.34 including HST; and
- 2. Set the expenditure authorization limit for Contract M.S. 1711-015-11 at \$1,200,000 including contingency and HST.

#### **SCOPE OF WORK**

The construction package related to this contract includes the construction of bus bays, sidewalks, curb bulges and other minor road improvements as listed in the following table and illustrated on the map attached as Appendix I:

The Engineer's pre-tender estimate was \$1,100,000, including HST.

#### **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Winvan Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond and has agreed to complete the work within 75 working days as stipulated in the tender documents. Winvan Paving Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Winvan Paving Ltd. be awarded Contract M.S. 1711-015-11.

#### **SUSTAINABILITY CONSIDERATIONS**

The work associated with this contract will assist in achieving the objectives of the City's Sustainability Charter related to efficiently moving people and goods, not just vehicles. The project will enhance the public realm by implementing street standards that minimize the negative impacts of transportation facilities on communities, while providing appropriate infrastructure in support of the City's transportation needs. In particular, the project supports the following Sustainability Charter Scope action items:

- SC 13: Creating a Fully Accessible City; and
- EN 13: Enhancing the Public Realm

Funding for this contract is available in the approved 2011 Capital Budget.
