SUBJECT: Amendment to the Vehicle for Hire By-law, 1999, No. 13610 -

Term of Chauffeur Permit

RECOMMENDATION

The Legal Services Division recommends that Council:

- 1. Receive this report as information; and
- 2. That Council adopt amendments to the City of Surrey Vehicle for Hire By-law, 1999, No. 13610 as documented in Appendix "A" to this report, which would bring into effect a Two-Year Chauffeur Permit for drivers who have a demonstrated record of responsible conduct and a safe driving record.

INTENT

At its Regular meeting on November 7, 2011, Council resolved

"That staff be requested to review the City's by-laws and policies related to Chauffeur Permits and forward a report to Council complete with recommendations with a view to allowing for the issuance of a 2-year Chauffeur Permit to taxi drivers that have demonstrated their good character and ability to operate their vehicle safely over a period of years."

This report responds to Council's resolution.

BACKGROUND

All taxi drivers in the City regardless of their length of service are currently required to renew their Chauffeur Permit annually with the City through the RCMP at a cost of \$125 for the application in addition to the expense associated with new photographs and the costs associated with attending at the local RCMP detachment to fill out the necessary application. This Chauffeur Permit process is focused on ensuring the safety of the public who use taxis. After a

taxi driver has demonstrated their good character and their ability to operate a vehicle safely over a number of years an annual review should not be necessary and, therefore, a longer period between Permit renewals could be considered. Should any issues of concern arise prior to the renewal of a Permit, the RCMP has the authority under the *Motor Vehicle Act* to suspend or cancel a Permit prior to its renewal date.

DISCUSSION

Staff has surveyed the practices of other municipalities in the lower mainland and has compiled the following information with respect to the term for which Chauffeur Permits are issued in other jurisdictions.

The purpose of the Chauffeur Permit application process is to ensure the safety of the public who use taxi services in Surrey. The Screening Guidelines that have been established for use by the RCMP in determining whether a Chauffeur Permit should be issued or renewed for an applicant are attached as Appendix "B". The Guidelines focus on the driving record of the applicant as well as the applicant's record of negative police contact and criminal record.

The amendments to the Vehicle for Hire By-law as proposed in this report provide that taxi drivers who have held a Chauffeur Permit for a minimum of five years and who have no more than two traffic violation tickets during the most recent five-year period, have no administrative driving prohibitions or penalties, have no criminal record or convictions for traffic-related offences during that same period and are not subject to a charge for an offence, will be eligible to receive a Two-Year Chauffeur Permit. These amendments will act as an incentive to taxi drivers to drive safely and to be responsible in relation to their conduct. If the RCMP have other concerns with the applicant, they are not obligated to issue a Two-Year Permit or any Permit for that matter based on the applicant satisfying the above-referenced criteria.

A two-year term for a Chauffeur Permit for qualifying taxi drivers is within the range of terms that are already in place in other municipalities in the Region.

CONCLUSION

Based on the above discussion, it is recommended that Council adopt an amendment to the City of Surrey Vehicle for Hire By-law, 1999, No. 13610 as documented in Appendix "A" to this report, which would act to implement a Two-Year Chauffeur Permit for drivers who have a demonstrated record of responsible conduct and a safe driving record.
