**Application for Funding for Surrey Projects** 

#### RECOMMENDATION

The Parks, Recreation & Culture Department and the Planning and Development Department recommend that Council:

- 1. Receive this report as information;
- 2. Approve the projects documented in Appendix I to this report, in the priority they are listed, as the basis for an application for project funding to the Community Infrastructure Improvement Fund (the "CIIF"); and
- 3. Authorize staff to submit such an application to the CIIF on behalf of the City of Surrey.

## **BACKGROUND**

The CIIF is a new two-year national program that will invest \$150 million to rehabilitate and improve community infrastructure across Canada. The program will help to modernize infrastructure and is intended to provide broad-based economic benefits to communities. CIIF is part of Canada's Economic Action Plan 2012, the Government of Canada's multi-faceted plan to aid in creating jobs, growth and prosperity.

#### DISCUSSION

The CIIF is focused on improving and enhancing existing community facilities, such as:

- Community centres;
- Cultural centres;
- Parks, recreational trails such as fitness trails, bike paths and other types of trails;
- Libraries:
- Recreational facilities, including local arenas, gymnasiums, swimming pools, sports fields, tennis, basketball, volleyball or other sport-specific courts, golf courses, ski hills or other types of recreational facilities;
- Tourism facilities having a local impact;
- Docks; and

 Other existing community infrastructure assets that have a local community impact, such as local roads, drinking water treatment and distribution systems, connectivity and broadband, local airports, solid-waste management and waste-water infrastructure.

Western Economic Diversification Canada will invest over \$46 million under the CIIF in Western Canada. Applicants to the CIIF seeking less than \$250,000 in funding will receive priority. Based on the program criteria issued by the federal government, total federal funding for a project cannot exceed 50% of total eligible project costs.

Projects will be selected based on readiness, funds leveraged, their ability to be completed by March 31, 2014 and economic benefits including the potential for job creation.

Based on the above-referenced criteria, staff has developed a list of shovel ready projects as documented in the attached Appendix I that appear to qualify for funding under the CIIF and is proposing that the City submit an application to the CIIF for funding for these projects in the priority in which they are listed in the Appendix.

### **SUSTAINABILITY CONSIDERATIONS**

The projects for which funding is being sought will assist in achieving the objectives of the City's Sustainability Charter; more particularly scope action items:

- SC5, SC6, and SC7: which address the social well being of Surrey residents, ensuring
  accessible and appropriately located services and enhancing citizen participation in leisure
  programs;
- EC1, EC3 and EC4: which address economic sustainability and maintenance of infrastructure; and
- EN10 and EN11: which address efforts by the City to address GHG emissions and climate change.

#### **CONCLUSION**

Based on the above discussion, it is recommended that Council:

- Approve the projects documented in Appendix I to this report, in the priority they are listed, as the basis for an application for project funding to the Community Infrastructure Improvement Fund; and
- Authorize staff to submit such an application to the CIIF on behalf of the City of Surrey.
