SUBJECT: 2014 Sponsor Appreciation Event

RECOMMENDATION

The Parks, Recreation and Culture Department and the Finance and Technology Department recommend that the Finance Committee recommend that Council approve an allocation of \$10,000 from the Council Initiatives Fund for the purpose of hosting a 2014 Sponsor Appreciation reception as generally described in this report.

BACKGROUND

The City hosts on an annual basis an evening reception to recognize and acknowledge the corporate sponsors of the City's special events of the previous year. In 2013, total sponsorship from corporate sponsors for City events amounted to approximately \$2.0 million. Without this level of sponsorship, the City would not have been able to provide the quality of events that Surrey's residents and visitors have come to expect. Surrey's special events also contribute significantly to enhancing the City's profile and image.

DISCUSSION

Based on feedback from sponsors and in consultation with the Mayor's Office, a 2014 sponsor appreciation event is being planned. The reception is proposed to be an evening event in late March at the New City Hall. Staff has identified 240 different sponsors of City events that will be invited to the reception. It is proposed that \$10,000 be allocated from the Council Initiatives Fund to fund this event. This is the same amount of funding that was allocated for this event in each of 2012 and 2013.

Status of Council Initiative Fund

Appendix "A" documents the status of the Council Initiatives Fund on an assumption that the recommendation of this report will be approved.

SUSTAINABILITY CONSIDERATIONS

The proposed sponsor appreciation reception supports the objectives of the City's Sustainability Charter; more particularly, the Cultural Sustainability Goal SC₄ (1), which is focused on ensuring the continuation of cultural activities as an important element of the City's annual programming.

CONCLUSION

Corporate sponsors have contributed significantly to the success of the City's special events. To recognize these sponsors, it is recommended that Council host a Sponsor Appreciation evening reception in March to which sponsors of the City special events will be invited. It is further recommended that \$10,000 be allocated from the Council Initiatives Fund to fund this evening reception.
