Non-Arterial Road Paving at Various Locations

RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1713-002-11 to Lafarge Canada Inc. C.O.B. as Columbia Bithulithic in the amount of \$837,381.77, including GST, for non-arterial road paving at various locations throughout the City; and
- 2. Set the expenditure authorization limit for Contract M.S. 1713-002-11 at \$921,000.00, including contingency and GST.

SCOPE OF WORK

The construction package related to this contract consists of road paving and patching on non-arterial roads at the locations listed in the following table and illustrated on the map attached as Appendix I.

The Engineer's pre-tender estimate was \$921,372.90, including GST.

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. One tender was found to be non-compliant and as such was rejected. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Lafarge Canada Inc. C.O.B. as Columbia Bitulithic, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 50 working days as stipulated in the Contract. Lafarge Canada Inc. C.O.B. as Columbia Bitulithic's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Lafarge Canada Inc. C.O.B. as Columbia Bitulithic be awarded Contract M.S. 1713-002-11.

SUSTAINABILITY CONSIDERATIONS

The proposed road construction works will prolong the life of the City's existing road infrastructure as well as provide smoother and quieter travel for both vehicles and cyclist

movement along these non-arterial roads. This contract will assist in achieving the objectives of the City's Sustainability Charter, which includes efficiently moving people and goods, not just vehicles. The project will also enhance the public realm by implementing street standards that minimize the negative impacts of transportation facilities on communities while providing appropriate infrastructure in support of the City's transportation needs. More particularly, the project supports the following Sustainability Charter Scope action items:

- SC 13: Creating a Fully Accessible City; and
- EN 13: Enhancing the Public Realm.


Funding for this Contract is available in the approved 2013 Budget.
