Construction of Sidewalks and Other Minor Transit Improvements

RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1713-009-11 to Winvan Paving Ltd. in the amount of \$1,379,122.17, including GST, for the construction of sidewalks and minor projects at various locations throughout the City; and
- 2. Set the expenditure authorization limit for Contract M.S. 1713-009-11 at \$1,517,000.00 including contingency and GST.

SCOPE OF WORK

The construction package related to this contract includes the construction of school-related sidewalks and transit improvements at the locations listed in the following table, which are also illustrated on the map attached as Appendix I to this report.

The Engineer's pre-tender estimate was \$1,430,000, including GST.

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Winvan Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 120 working days as stipulated in the contract. Winvan Paving Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Winvan Paving Ltd. be awarded Contract M.S. 1713-009-11.

SUSTAINABILITY CONSIDERATIONS

The work associated with this contract will assist in achieving the objectives of the City's Sustainability Charter related to safely and efficiently moving people and goods, not just vehicles, and promoting active living. The project will also act to enhance the public realm by implementing street standards that minimize the negative impacts of transportation facilities on communities while providing appropriate infrastructure in support of the City's transportation needs. More particularly, the project supports the following Sustainability Charter scope action items:

- SC 13: Creating a Fully Accessible City; and
- EN 13: Enhancing the Public Realm.

FUNDING


Funding for this contract is available in the approved 2013 Budget.
