### RECOMMENDATION

- The details of any municipal contract with Council members as reported under Section 107 of the *Community Charter*.

The information documented in Appendices "A" to "J" attached to this report for the members of Council, respectively, satisfies the requirements of Section 168 of the Community Charter.
