**Construction of Traffic Safety Improvements** 

## RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1713-003-11 to Imperial Paving Limited in the amount of \$1,737,109.08, including GST, for the construction of traffic safety improvements at various locations throughout the City, as generally described in this report; and
- 2. Set the expenditure authorization limit for Contract M.S. 1713-003-11 at \$1,911,000 including contingency and GST.

## **SCOPE OF WORK**

The construction package related to this contract includes the construction of traffic safety improvements such as sidewalks, curb bulges and roundabouts at the locations listed in the following table, which are also illustrated on the map attached as Appendix I to this report.

The Engineer's pre-tender estimate was \$1,730,000, including GST.

## **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Imperial Paving Limited, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 130 working days as stipulated in the contract. Imperial Paving Limited's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Imperial Paving Limited be awarded Contract M.S. 1713-003-11.

## **SUSTAINABILITY CONSIDERATIONS**

The work associated with this contract will assist in achieving the objectives of the City's Sustainability Charter related to safely and efficiently moving people and goods, not just vehicles, and promoting active living. The project will also act to enhance the public realm by implementing street standards that minimize the negative impacts of transportation facilities on communities while providing appropriate infrastructure in support of the City's transportation

needs. More particularly, the project supports the following Sustainability Charter scope action items:

- SC 13: Creating a Fully Accessible City; and
- EN 13: Enhancing the Public Realm.

## **FUNDING**


Funding for this contract is available in the approved 2013 Budget.
