SUBJECT: Local Area Service - Infrastructure Improvements along Musqueam Drive at

12009, 12031, 12233 and 12195 Musqueam Drive - Final Costs and Apportionment By-law No. 17611

RECOMMENDATION

The Engineering Department and the Finance & Technology Department recommend that Council:

- Approve amendments to "Local Area Service Utilities Extension and Road Improvement (Project # 1211-0560) By-law, 2012, No. 17611" to reflect the final costs of construction of the works covered by the By-law and the apportionment thereof across the benefiting properties all as detailed in Appendix II attached to this report; and
- 2. Authorize the City Clerk to bring forward the necessary amendment By-law, a copy of which is attached as Appendix I to this report, for the required readings and final adoption.

INTENT

The purpose of this report is to provide information about the final project costs related to "Local Area Service Utilities Extension and Road Improvement (Project # 1211-0560) By-law, 2012, No. 17611" and to obtain approval to bring forward an amendment By-law to apportion the final costs of construction of the project across the benefiting properties.

DISCUSSION

At its Regular meeting on April 2, 2012 Council approved the recommendations of Corporate Report No. Ro61;2012 thereby approving the use of a Local Area Service (LAS) initiative as the means by which to finance the construction of a sanitary sewer main extension, a water main extension, drainage improvements and local road improvements across the frontage of lots fronting Musqueam Drive, more specifically the lots at 12009, 12031, 12233, and 12195 Musqueam Drive all as illustrated in Appendix III attached to this report.

Following a successful property owner petitioning process, which is a necessary part of the LAS procedure, Council approved the LAS by way of Council Resolution No. R12-957. Subsequently, Local Area Service Utilities Extension and Road Improvement (Project # 1211-0560) By-law, 2012,

No. 17611 was given the required readings. The construction work has now been completed and final costs of construction have been determined. The final cost of the works was approximately 12% lower than the estimate that was originally provided to the owners of the properties within the benefiting area.

Based on the Completion Certificate, which is attached as Appendix IV to this report, the works authorized under By-law No. 17611 were completed at a cost of \$2,623,514.94.

Appendix II attached to this report details the apportionment of the final costs of the project to the benefiting properties.

CONCLUSION

Based on the above discussion, it is recommended that Council:

- Approve amendments to "Local Area Service Utilities Extension and Road Improvement (Project # 1211-0560) By-law, 2012, No. 17611" to reflect the final costs of construction of the works covered by the By-law and the apportionment thereof across the benefiting properties all as detailed in Appendix II attached to this report; and
- Authorize the City Clerk to bring forward the necessary amendment By-law, a copy of which is attached as Appendix I to this report, for the required readings and final adoption.




