Summary Explanation of By-law Infractions by Category:

<u>Secondary Suite Compliance</u> – Investigations relating to the removal of existing known unauthorized secondary suites, identification of secondary suites to ensure appropriate City fees are paid; and the removal of multiple secondary suites from homes.

Zoning and Building By-law Investigations – Investigations relating to the use of property as regulated by the Zoning By-law. Typical investigations include such things as the parking of overweight vehicles on residential property, truck parking in agricultural areas, storage of wrecked vehicles, the unauthorized keeping of animals (chickens, horses, cows), etc.

<u>Business License By-law Investigations</u> – Investigations relating to businesses located in the City. These investigations include such things as following up on safety inspections performed as part of the business license application process, ensuring that businesses are following Zoning, Building and Business License regulations in the operation of their business, etc.

<u>Conservation Investigations</u> – Investigations related to construction sites and agricultural properties to ensure regulations for soil deposit or removal, erosion and sediment control and water protection are being followed.

<u>Tree Protection Investigations</u> – By-law Enforcement staff assists the Trees and Landscaping Section staff in the administration of the Tree Preservation By-law, by gathering evidence and drafting charges against those who contravene the By-law.

<u>Noise Control Investigations</u> – Investigations related to various types of nuisance noise in the City (e.g., construction when not permitted, barking dogs, loud music, etc.).

<u>Dog Responsibility By-law Investigations</u> – Investigations into animal control files related to dogs at large, dangerous dogs, dog bites/attacks, collecting stray animals, etc.

<u>Highway and Traffic Investigations</u> – By-law Officers assist with parking issues that require immediate attendance (blocked driveways or roadways) or extended contact with vehicle owners or RCMP (e.g., abandoned vehicles).

<u>Public Health (Smoking) Investigations</u> – Investigations related to complaints of smoking in public places where smoking is prohibited by By-law.

<u>Graffiti, Property Maintenance and Unsightly Premises Investigations</u> – Investigations related to the Property Maintenance and Unsightly Property By-law. By-law Enforcement Officers work with owners to have problem properties cleaned up; if no voluntary compliance is gained, the City may enter onto the property to effect the clean up and invoice the property owner.

<u>Sign By-law Investigations</u> – Investigations related to unauthorized signage on City and private property.

<u>Parks By-law Violations</u> – Investigations related to unauthorized use of parks as regulated by the Parks Regulation By-law.


<u>Abandoned Properties Investigations</u> – Investigations related to abandoned buildings including identifying and securing such properties for public safety reasons.

<u>Controlled Substance Property Investigations</u> – Investigations related to properties that have been identified by the RCMP, the Fire Department or the Electrical Fire Safety Initiative Team as containing controlled substance production. Officers act to ensure regulations are met and that the property is remediated or demolished.

<u>Miscellaneous Investigations</u> – Investigations where by-law officers assist other Departments or deal with infrequent types of complaints.







It is noted that there has been a noticeable increase in the rate of suite registrations since the introduction by the City of a penalty fee associated with the City locating secondary suites that are not registered with the City. This penalty fee of \$1000 was introduced by By-law in October to take effect in February 2014. Property owners are coming forward to register their suites with a view to avoiding the penalty when it comes into effect.
