SUBJECT: Award of Contract M.S. 1714-008-11

Traffic Signals and Pedestrian Signalized Crosswalk Installations at Various

Locations

#### RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1714-008-11 to Winvan Paving Ltd. in the amount of \$3,371,419.14, including GST, for traffic and pedestrian signal installations at various locations throughout the City; and
- 2. Set the expenditure authorization limit for Contract M.S. 1714-008-11 at \$3,708,600.00, including GST and contingency.

#### **SCOPE OF WORK**

The construction package related to this Contract consists of traffic signals, intersection improvements and signalized pedestrian crossings at 17 locations in the City, as listed in the following table and illustrated on the map attached as Appendix I.

Eight (8) of the locations are pedestrian signals being constructed as part of the City's Safe and Active Schools program. This year the City is investing over \$4 million to improve safety for children around our schools. This significant investment will complete all of the short term improvements and some of the medium term improvements identified in our comprehensive study of every school in Surrey.

The Engineer's pre-tender estimate was \$3,779,993.28, including GST.

#### **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. There was one arithmetic error that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Winvan Paving Ltd., has provided a Consent of Surety for a Performance Bond as well as a Labour & Materials Bond, and agreed to complete the work within 150 working days as stipulated in the contract. Their past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Winvan Paving Ltd. be awarded Contract M.S. 1714-008-11.

## **SUSTAINABILITY CONSIDERATIONS**

This contract will assist in achieving the objectives of the City's Sustainability Charter, which includes efficiently moving people and goods, not just vehicles. In alignment with the goals of the Sustainability Charter, the works will also enhance the public realm by implementing street standards that minimize the negative impacts of transportation facilities on communities, while providing appropriate infrastructure in support of the City's transportation needs. In particular, the work of the contract will assist in achieving the following Surrey Sustainability Charter Scope action items:

- SC 13: Creating a Fully Accessible City; and
- EN 13: Enhancing the Public Realm.


Funding for this contract is available in the approved 2014 Transportation Budget.
