SUBJECT: Award of Contract M.S. 1213-001-11

Water Main Installations at Various Locations

RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1213-001-11 to Hyland Excavating Ltd. in the amount of \$3,676,787.10, including GST, for installation of water main, service connections and related appurtenances; and
- 2. Set the expenditure authorization limit for Contract M.S. 1213-001-11 at \$4,045,000.00 including GST and contingency.

SCOPE OF WORK

The work related to this contract consists of construction of major water mains to service population growth. Locations of the four (4) projects are listed in the following table, which are also illustrated on the map attached to this report as Appendix I:

The contract work is expected to start by July 28, 2014, and be completed by January, 2015.

TENDER RESULTS

Tenders for the subject contract were opened on June 17, 2014 with the following results:

The Engineer's pre-tender estimate was \$4,095,000 including GST.

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness and no errors were found. All submissions included the required 10% bid bond, and were signed and sealed on the Tender Form and Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Hyland Excavating Ltd. (Hyland), has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 120 working days, as stipulated in the contract. Hyland's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Hyland be awarded Contract M.S. 1213-001-11.

SUSTAINABILITY CONSIDERATIONS

The work of this contract will minimize operational and maintenance costs and facilitates the development of the adjacent private property. In particular, the project supports the following Sustainability Charter Scope actions:

- EC3: Sustainable Infrastructure Maintenance and Replacement; and
- EN8: Sustainable Engineering Standards and Practice.


