SUBJECT: Local Area Service - Water Main Extension along 176 Street from the BC

Railway to the Nicomekl River and along 48 Avenue from 176 Street to 17188 -

48 Avenue - Final Costs and Apportionment Bylaw No. 17488

RECOMMENDATIONS

The Engineering Department and the Finance & Technology Department recommend that Council:

- 1. Approve amendments to "Local Area Service (LAS) Water Main Extension (Project # 1211-901) By-law, 2011, No. 17488" to reflect the final costs of construction of the works covered by the By-law and the apportionment thereof among the benefiting properties all as detailed in Appendix II attached to this report; and
- 2. Authorize the City Clerk to bring forward the necessary amendment By-law, a copy of which is attached as Appendix I to this report, for the required readings and final adoption.

INTENT

The purpose of this report is to advise Council of the final project costs related to "Local Area Service (LAS) Water Main Extension (Project # 1211-901) By-law, 2011, No. 17488" and to obtain Council approval to forward an amendment By-law to apportion the final costs of construction of the project across the benefiting properties.

DISCUSSION

At its Regular Meeting on October 3, 2011 Council approved the recommendations of Corporate Report No. R182;2011 thereby approving the use of a Local Area Service (LAS) initiative as the means by which to finance the construction of a water main extension across the frontage of lots fronting 176 Street and 48 Avenue as illustrated specifically in Appendix III attached to this report.

Following a successful property owner petitioning process, which is a necessary part of the LAS procedure, Council approved the LAS by way of Council Resolution No. R11-1837. Subsequently, "Local Area Service (LAS) Water Main Extension (Project # 1211-901) By-law, 2011, No. 17488" was given the required readings.

The LAS project was then issued for tender. Tenders for the subject contract were opened on February 15, 2013. The lowest bid received by the City was \$1,032,305.71, while the estimate that the LAS petition was based on was \$763,000. In accordance with Engineering Department Practice, any LAS project whose cost exceeds 110% of the original estimate can only proceed if the majority of the benefiting properties do not oppose the new costs. As such, a new petition asking property owners within the benefiting areas if they oppose the new project costs was issued. The results of the new petition confirmed that the owners did not oppose the increased project cost and as a result the project proceeded.

Now the construction work has been completed and final costs of construction have been determined. The final cost of the works is approximately 2% lower than the revised estimate that was provided to the owners of the properties within the benefiting areas.

Based on the Completion Certificate, included in Appendix IV to this report, the works authorized under the Construction By-law No. 17488 were completed at a cost of \$1,014,529.18.

Appendix II attached to this report details the apportionment of the final costs of the project to the benefitting properties.

CONCLUSION

Based on the above discussion, it is recommended that Council:

- Approve amendments to "Local Area Service (LAS) Water Main Extension (Project # 1211-901) By-law, 2011, No. 17488" to reflect the final costs of construction of the works covered by the By-law and the apportionment thereof among the benefiting properties all as detailed in Appendix II attached to this report; and
- Authorize the City Clerk to bring forward the necessary amendment By-law, a copy of which is attached as Appendix I to this report, for the required readings and final adoption.


