 SUBJECT: **Award of Contract M.S. 1715-008-11
 Semiahmoo Trail and Crescent Road Pathway and Pedestrian Crossing
 Improvements**

RECOMMENDATIONS

The Engineering Department recommends that Council:

1. Award Contract M.S. 1715-008-11 to Martens Asphalt Ltd. in the amount of \$670,542.83, including GST, for the Semiahmoo Trail and Crescent Road Pathway and Pedestrian Crossing Improvements; and
2. Set the expenditure authorization limit for Contract M.S. 1715-008-11 at \$738,000, including GST and contingency.

SCOPE OF WORK

The construction package related to this contract consists of a new gravel pathway and sidewalk on Crescent Road from Nico Wynd Drive to 143 Street, Semiahmoo Trail greenway improvements between 143 Street and 144 Street, and a pedestrian crosswalk across Crescent Road at Elgin Road, which are summarized in the following table and illustrated on the map attached to this report as Appendix I:

The contract work is expected to start on January 11, 2016, and be completed by March 2016.

TENDER RESULTS

Tenders for the subject contract were opened on November 17, 2015 with the following results:

The Engineer's (WEB Engineering Ltd.) pre-tender estimate was \$700,000 including GST.

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, were signed and sealed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Martens Asphalt Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 40 working days, as stipulated in the contract. Martens Asphalt Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Martens Asphalt Ltd. be awarded Contract M.S. 1715-008-11.

SUSTAINABILITY CONSIDERATIONS

This contract will assist in achieving the vision of the City's Sustainability Charter, which includes efficiently moving people and goods, not just vehicles, and promoting active living. In alignment with the goals of the Sustainability Charter, the project will also enhance the public realm by implementing street standards that minimize the negative impacts of transportation facilities on communities, while providing appropriate infrastructure in support of the City's transportation needs. In particular, the project supports the following Charter Scope actions:

- SC 13: Creating a Fully Accessible City; and
- EN 13: Enhancing the Public Realm.

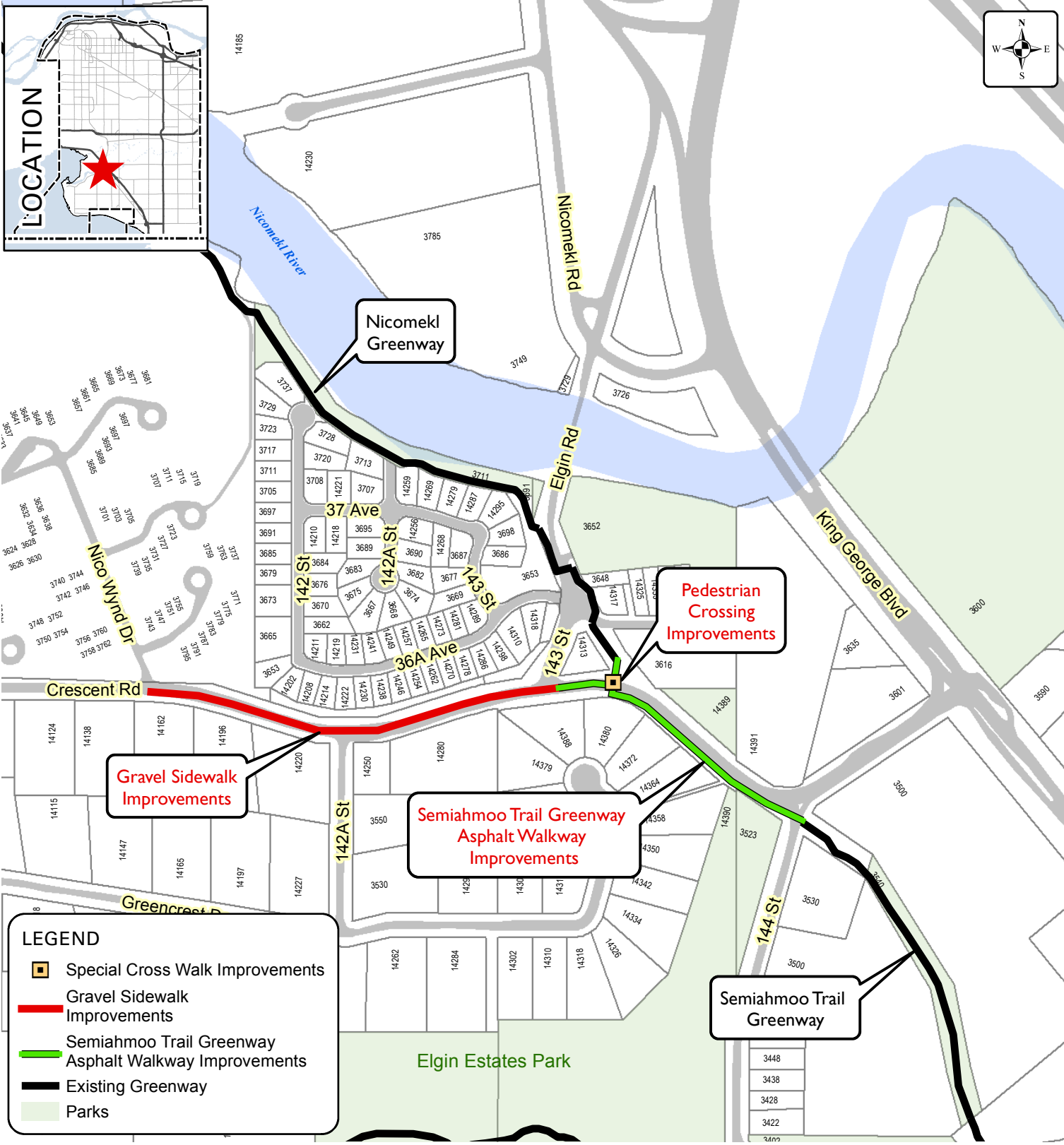
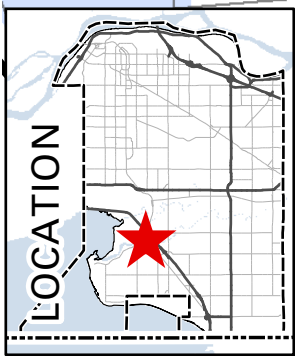
FUNDING
