SUBJECT: Proposed Amendments to Delegation By-law, 2006, No. 15913

RECOMMENDATION

The Planning and Development Department recommends that Council:

- 1. Receive this report as information;
- 2. Approve an amendment to Delegation By-law, 2006, No. 15913 (the "Delegation By-law"), as documented in Appendix I of this report; and
- 3. Authorize the City Clerk to bring forward the necessary amendment by-law for the required readings.

INTENT

The purpose of this report is to bring forward a minor amendment to the Delegation By-law to include Section 961 of the *Local Government Act*, which, if adopted, will allow staff to withhold demolition permits for registered or protected heritage buildings until other approvals, such as a building permit, are issued.

BACKGROUND

A recent review of the Delegation By-law has found that the by-law is deficient, and does not include Section 961 of the *Local Government Act*. Section 961 addresses the pre-emptive demolition of heritage buildings without a redevelopment plan for the site, and allows staff the opportunity to work with heritage property owners towards the retention of heritage buildings.

DISCUSSION

Section 961 of the *Local Government Act* authorizes a local government to withhold a demolition permit for protected heritage property and property identified in a community heritage register until either a heritage alteration permit or a building permit and any other necessary approvals have been issued. To address the potential circumstance in which a demolition permit application for a heritage property is made during the August Council recess, it is recommended that Council delegate its powers under Section 961 of the *Local Government Act* to the General Manager, Planning and Development.

The proposed amendment to the Delegation By-law is documented in Appendix I to this report.

CONCLUSION

Based on the above discussion it is recommended that Council:

- Approve an amendment to Delegation By-law, 2006, No. 15913 (the "Delegation By-law"), as documented in Appendix I of this report; and
- Authorize the City Clerk to bring forward the necessary amendment by-law for the required readings.
