Watermain Replacements in the Fleetwood Area

#### RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1216-002-11 to TAG Construction Ltd. in the amount of \$1,209,174.75, including GST, for construction of distribution watermain replacements in the Fleetwood area; and
- 2. Set the expenditure authorization limit for Contract M.S. 1216-002-11 at \$1,330,000, including contingency and GST.

#### **SCOPE OF WORK**

The construction package related to this contract consists of installation of distribution watermains at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I". The major components of the contract include construction of distribution watermains to replace aging asbestos cement watermains in the Fleetwood area.

The Engineer's (ISL Engineering and Land Services Ltd.) pre-tender estimate was \$1.39 million including GST.

#### **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. There was one arithmetic error that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialled on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, TAG Construction Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 70 working days, as stipulated in the contract. TAG Construction Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that TAG Construction Ltd. be awarded Contract M.S. 1216-002-11.

#### SUSTAINABILITY CHARTER/CONSIDERATIONS

The work of this contract will minimize operational and maintenance costs and facilitate the development and servicing of the adjacent properties. In particular, the project supports the following Sustainability Charter Scope actions:

- EC3: Sustainable Infrastructure Maintenance and Replacement; and
- EN8: Sustainable Engineering Standards and Practice.


