### RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1716-003-11 to Winvan Paving Ltd. in the amount of \$2,458,414.61, including GST, for the 2016 Minor Road Paving Program; and
- 2. Set the expenditure authorization limit for Contract M.S. 1716-003-11 at \$2,705,000.00, including GST and contingency.

### **SCOPE OF WORK**

The construction package related to this contract consists primarily of road reconstruction, milling, paving, and drainage conveyance measures at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I":

The contract work is expected to start on May 24, 2016, and be completed by September 2016.

## **TENDER RESULTS**

Tenders for the subject contract were opened on March 31, 2016 with the following results:

The Engineer's (McElhanney Consulting Services Ltd.) pre-tender estimate was \$2,332,157.26 including GST.

### **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Winvan Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 75 working days, as stipulated in the contract. Winvan Paving Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Winvan Paving Ltd. be awarded Contract M.S. 1716-003-11.

### SUSTAINABILITY CONSIDERATIONS

The proposed road improvements will prolong the life of the existing road structure, as well as provide smoother and quieter travel for both vehicle and cyclist movement along these roads, supporting the Sustainability Charter's vision of efficiently moving people and goods, not just vehicles. The project will enhance the public realm by implementing street standards that minimize the negative impacts of transportation facilities on communities, while providing appropriate infrastructure in support of the City's transportation needs. In particular, the project supports the Charter Scope actions related to:

- SC 13: Creating a Fully Accessible City; and
- EN 13: Enhancing the Public Realm.

### **FUNDING**


Funding for this contract is available in the approved 2016 Transportation Budget.
