SUBJECT: Award of Contract M.S. 4716-003-11

Sullivan Heights and Various Locations Sanitary Sewer Construction

RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 4716-003-11 to Sandpiper Contracting LLP in the amount of \$2,184,123.43, including GST, for the construction of Sullivan Heights and Various Locations Sanitary Sewer Construction package;
- 2. Set the expenditure authorization limit for Contract M.S. 4716-003-11 at \$2,400,000.00, including contingency and GST; and
- 3. Authorize the General Manager, Engineering to execute Contract M.S. 4716-003-11 to a maximum of \$2,400,000.00, including GST and contingency.

SCOPE OF WORK

The construction package related to this contract consists of upgrading existing sanitary sewer mains at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I". The sanitary sewer improvements are to replace existing sewers that are undersized and sewers that have sagged/deflected resulting in high operational and maintenance costs.

The contract work is expected to start in June 2016 and be completed by the end of October 2016.

TENDER RESULTS

Tenders for the subject contract were opened on April 27, 2016, with the following results:

The Engineer's (ISL Engineering and Land Services Ltd.) pre-tender estimate was \$2.0 million including GST.

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. Both submissions included the required 10% bid bond, were signed on the Tender Form, and were initialled on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Sandpiper Contracting LLP, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 60 working days as stipulated in the contract. Sandpiper Contracting LLP's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Sandpiper Contracting LLP be awarded Contract M.S. 4716-003-11.

SUSTAINABILITY CHARTER/CONSIDERATIONS

The work of this contract will minimize operational and maintenance costs and facilitate the servicing of the adjacent properties. In particular, the project supports the following Sustainability Charter Scope actions:

- EC3: Sustainable Infrastructure Maintenance and Replacement; and
- EN8: Sustainable Engineering Standards and Practice.

FUNDING


Funding for the subject contract is available in the approved 2016 Budget.
