RECOMMENDATIONS

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 4815-053-31 to Pedre Contractors Ltd. in the amount of \$2,266,950.00, including GST, for the construction of the Miscellaneous Utility Improvements Construction package;
- 2. Set the expenditure authorization limit for Contract M.S. 4815-053-31 at \$2,493,645.00, including contingency and GST; and
- 3. Authorize the General Manager, Engineering to execute Contract M.S. 4815-053-31 to a maximum of \$2,493,645.00, including GST and contingency.

SCOPE OF WORK

The construction package related to this contract consists of upgrading existing utilities at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I".

The neighbourhood surrounding Bailey Crescent is an older, single-family, residential area that has experienced flooding from time to time due to the aging storm sewer system in the area. This project consists of renewing the storm sewer network along Bailey Crescent which will improve the overall drainage conveyance for the neighbourhood.

The existing storm and sanitary sewer located near 82 Avenue and 128 Street are in poor repair and are difficult to access as they cross the Southern Railway corridor and are contained within an existing right-of-way in the rear of large, private, industrial properties. The proposed utility improvements involve replacing the storm and sanitary sewer and relocating them to within the City's road allowance allowing for improved access for maintenance. To minimize construction costs, the existing water main crossing the Southern Railway is being replaced under this contract, as it was originally planned for replacement in 2017.

The contract work is expected to start in July 2016 and be completed by the end of November 2016.

TENDER RESULTS

Tenders for the subject contract were opened on June 9, 2016, with the following results:

The Engineer's (Tetra Tech EBA Inc.) pre-tender estimate was \$2.1 million including GST.

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. There was one arithmetic error that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialled on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Pedre Contractors Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 80 working days as stipulated in the contract. Pedre Contractors Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Pedre Contractors Ltd. be awarded Contract M.S. 4815-053-31.

SUSTAINABILITY CHARTER/CONSIDERATIONS

The City is responsible for effective and sustainable design, construction and maintenance of infrastructure assets to provide safe and reliable services to our residents and businesses, while also ensuring the infrastructure meets the demands of future growth and economic development. FUNDING


Funding for the subject contract is available in the approved 2016 Budget.
