RECOMMENDATIONS

The Engineering Department and the Finance & Technology Department recommend that Council:

- 1. Approve amendments to Local Area Service Sanitary Sewer Main Extension [Project # 4714-902] Bylaw, 2014, No.18294 to reflect the final costs of construction covered by the Bylaw and the apportionment thereof across the benefitting properties all as detailed in Appendix "II" attached to this report; and
- 2. Authorize the City Clerk to bring forward the necessary amendment Bylaw, a copy of which is attached as Appendix "I" to this report, for the required readings and final adoption.

INTENT

The purpose of this report is to advise Council of the final project cost related to *Local Area Service Sanitary Sewer Main Extension [Project # 4714-902] Bylaw, 2014, No.18294* and to obtain Council approval to bring forward an amendment Bylaw to ensure the cost apportionment across the benefiting properties reflects the final costs of construction of the project.

DISCUSSION

At its Regular meeting on September 8, 2014, Council approved the recommendations of Corporate Report No. R149;2014, thereby approving the use of a Local Area Service (LAS) initiative as the means by which to finance the construction of a sanitary sewer main to provide service to the lots fronting 133 Street between 5729 - 133 Street and 5785 - 133 Street, as illustrated in Appendix "III" attached to this report.

Following a successful property owner petitioning process, which is a necessary part of the LAS procedure, Council approved the LAS by way of Council Resolution No. R14-1599. Subsequently, Local Area Service Sanitary Sewer Main Extension [Project # 4714-902] Bylaw, 2014, No.18294 was given the required readings.

The construction work has now been completed and final costs of the construction have been determined. The final cost of the works is approximately 7.3% below the estimate that was originally provided to the owners of the properties within the benefiting area.

Based on the Completion Certificate, which is included as Appendix "IV" attached to this report, the works authorized under Bylaw No. 18294 were completed at a cost of \$179,805.00.

Appendix "II" attached to this report details the apportionment of the final costs of the project to the benefiting properties.

SUSTAINABILITY CONSIDERATIONS

This project supports the objectives of the City's Sustainability Charter. In particular, the sanitary sewer main extension on 133 Street relates to the Sustainability Charter theme of Infrastructure. Specifically, this project supports the following Desired Outcomes:

- All Infrastructure DO1: City facilities and infrastructure systems are well managed, adaptable and long lasting, and are effectively integrated into regional systems;
- All Infrastructure DO2: Infrastructure systems provide safe, reliable and affordable services; and
- All Infrastructure DO3: Infrastructure systems are designed to protect human health, preserve environmental integrity, and be adaptable to climate change impacts.

CONCLUSION

Based on the above discussion, it is recommended that Council:

- Approve amendments to *Local Area Service Sanitary Sewer Main Extension [Project # 4714-902] Bylaw, 2014, No.18294* to reflect the final costs of construction covered by the Bylaw and the apportionment thereof across the benefitting properties all as detailed in Appendix "II" attached to this report; and
- Authorize the City Clerk to bring forward the necessary amendment Bylaw, a copy of which is attached as Appendix "I" to this report, for the required readings and final adoption.


