SUBJECT: Award of Contract M.S. 4815-051-11

North Robson Drainage and Sanitary Works

RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 4815-051-11 to Sandpiper Contracting LLP in the amount of \$3,590,721.75, including GST, for construction of drainage and sanitary sewer replacements at various locations throughout North Surrey;
- 2. Set the expenditure authorization limit for Contract M.S. 4815-051-11 at \$3,950,000.00, including GST and contingency; and
- 3. Authorize the General Manager, Engineering to execute Contract M.S. 4815-051-11.

SCOPE OF WORK

The construction package related to this contract consists of the installation of 1,178 metres of storm sewer and 1,608 metres of sanitary sewer replacements and surface repaving. The works are throughout the North Robson area. The drainage improvements are to replace aging infrastructure and to improve the level of service by increasing capacity. The sanitary improvements are to eliminate existing rear yard right-of-way systems that are hard to access and maintain. The project locations are listed in the following table, and are also illustrated on the map attached to this report as Appendix "I":

The contract work is expected to start on April 24, 2017 and be completed by November 30, 2017.

TENDER RESULTS

Tenders for the subject contract were opened on March 23, 2017 with the following results:

The Engineer's (McElhanney Consulting Services Ltd.) pre-tender estimate was \$3.5 million including GST.

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. There was one arithmetic error that had no bearing on the outcome of the tender. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Sandpiper Contracting LLP, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 140 working days, as stipulated in the contract. Sandpiper Contracting LLP's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Sandpiper Contracting LLP be awarded Contract M.S. 4815-051-11.

SUSTAINABILITY CONSIDERATIONS

The work of this contract supports the objectives of the City's Sustainability Charter. In particular, the replacement of these storm and sanitary mains supports the Sustainability Charter theme of Infrastructure by minimizing operational and maintenance costs, and facilitating the development and servicing of the adjacent properties. Specifically, this contract supports the following Desired Outcomes:

- All Infrastructure DO1: City facilities and infrastructure systems are well managed, adaptable and long lasting, and are effectively integrated into regional systems;
- All Infrastructure DO2: Infrastructure systems provide safe, reliable and affordable services; and
- All Infrastructure SD1: Proactively manage community assets to maintain them over the long-term in a state of good repair.

FUNDING


Funding for this contract is available in the approved 2017 Storm and Sanitary Budget.
