SUBJECT:	Award of Contract M.S. 1716-076-11 2017 Minor Road Paving Program		

RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1716-076-11 to Winvan Paving Ltd. in the amount of \$2,937,438.98, including GST, for the 2017 Minor Road Paving Program;
- 2. Set the expenditure authorization limit for Contract M.S. 1716-076-11 at \$3,230,000.00, including GST and contingency; and
- 3. Authorize the General Manager, Engineering to execute Contract M.S. 1716-076-11.

SCOPE OF WORK

The paving construction package related to this contract consists primarily of road rehabilitation, concrete works and streetlight works at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I":

The contract work is expected to start on May 15, 2017 and be completed by September 30, 2017.

TENDER RESULTS

Tenders for the subject contract were opened on April 5, 2017 with the following results:

The Engineer's (McElhanney Consulting Services Ltd.) pre-tender estimate was \$2.79 million including GST.

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. There was one minor arithmetic error which had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Winvan Paving Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 100 working days, as stipulated in the contract. Winvan Paving Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Winvan Paving Ltd. be awarded Contract M.S. 1716-076-11.

SUSTAINABILITY CONSIDERATIONS

This project supports the objectives of the City's Sustainability Charter. In particular, this project relates to the Sustainability Charter theme of Infrastructure. Specifically, this contract supports the following Desired Outcomes:

- All Infrastructure DO1: City facilities and infrastructure systems are well managed, adaptable and long lasting, and are effectively integrated into regional systems; and
- All Infrastructure SD1: Proactively manage community assets to maintain them over the long-term in a state of good repair.


FUNDING

Funding for this contract is available in the approved 2017 Transportation Budget.


