2017 School Sidewalk and Traffic Calming

## RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract M.S. 1717-007-11 to Jack Cewe Ltd. in the amount of \$2,528,400.00, including GST, for the 2017 School Sidewalk and Traffic Calming project;
- 2. Set the expenditure authorization limit for Contract M.S. 1717-007-11 at \$2,700,000.00, including GST and contingency; and
- 3. Authorize the General Manager, Engineering to execute Contract M.S. 1717-007-11.

## **SCOPE OF WORK**

The construction package related to this contract consists of similar sidewalk and traffic calming projects at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I". This contract is primarily school sidewalks and greenways throughout the City. Seven (7) of these projects are part of the City's 2017 Safe and Active Schools Program.

The contract work is expected to start on May 29, 2017 and be completed by late October 2017.

#### **TENDER RESULTS**

Tenders for the subject contract were opened on April 25, 2017 with the following results:

The Engineer's (Aplin & Martin Consultants Ltd.) pre-tender estimate was \$2,460,000.00 including GST.

#### **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Jack Cewe Ltd., has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 100 working days, as stipulated in the contract. Jack Cewe Ltd.'s past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Jack Cewe Ltd. be awarded Contract M.S. 1717-007-11.

#### **SUSTAINABILITY CONSIDERATIONS**

This project supports the objectives of the City's Sustainability Charter. In particular, this project relates to the Sustainability Charter theme of Infrastructure. Specifically, this contract supports the following Desired Outcomes:




