SUBJECT: Award of Contract No. 1217-053-11

North Surrey Water Main Construction

RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract No. 1217-053-11 to Sandpiper Contracting LLP ("Sandpiper") in the amount of \$3,684,619.05, (including GST), for the construction of new water mains at various locations (see Appendix "I");
- 2. Set the expenditure authorization limit for Contract No. 1217-053-11 at \$4,100,000.00 (including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1217-053-11.

SCOPE OF WORK

The construction package related to Contract No. 1217-053-11 (the "Contract") consists of the installation of ten projects at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I":

The Contract work is expected to start in April 2018 and be completed by October 2018.

TENDER RESULTS

Tenders for the subject Contract were opened on March 15, 2018 with the following results:

The Engineer's (ISL Engineering) pre-tender estimate was \$4.1 million (including GST).

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. There was one arithmetic error that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Sandpiper, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 125 working days, as stipulated in the Contract. Sandpiper's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Sandpiper be awarded Contract No. 1217-053-11.

SUSTAINABILITY CONSIDERATIONS

The work of this Contract supports the objectives of the City's Sustainability Charter 2.o. In particular, this work relates to the Sustainability Charter 2.o theme of Infrastructure. Specifically, this project supports the following Desired Outcomes:

- All Infrastructure DO1: City facilities and infrastructure systems are well managed, adaptable and long lasting, and are effectively integrated into regional systems;
- All Infrastructure DO3: Infrastructure systems provide safe, reliable and affordable services; and
- Water DO17: Water is efficiently and fairly distributed to support agricultural needs while maintaining ecological functions.


Funding for this Contract is available in the approved 2018 Utilities Budget.
