2018 Safe and Active Schools Program Sidewalk Package - Phase 1

RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract No. 1717-012-11 to Mainland Construction Materials ULC dba Winvan Paving in the amount of \$1,799,004.59, (including GST), for the 2018 Safe and Active Schools Program Sidewalk Package Phase 1;
- 2. Set the expenditure authorization limit for Contract No. 1717-012-11 at \$1,980,000.00, (including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1717-012-11.

SCOPE OF WORK

The construction package related to this Contract consists of similar sidewalk projects at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I".

This Contract is primarily concrete sidewalks with curb and gutter and street lights on Local, Collector and Arterial roads throughout the City. All of these projects are part of the City's 2018 Safe and Active Schools Program.

The Contract work is expected to start on May 22, 2018 and be completed by November 9, 2018.

TENDER RESULTS

Tenders for the subject Contract were opened on April 03, 2018 with the following results:

The Engineer's (R.F. Binnie & Associates Ltd.) pre-tender estimate was \$2,050,000.00 (including GST).

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. There was one arithmetical error that had no bearing on the outcome of the tender process. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Winvan Paving, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 125 working days, as stipulated in the Contract. Winvan Paving's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that Mainland Construction Materials ULC dba Winvan Paving be awarded Contract No. 1717-012-11.

SUSTAINABILITY CONSIDERATIONS

This project supports the objectives of the City's Sustainability Charter 2.0. In particular, this project relates to the Sustainability Charter 2.0 theme of Infrastructure. Specifically, this Contract supports the following Desired Outcome (DO) and Strategic Direction (SD):


Funding for this Contract is available in the approved 2018 Transportation Budget.
