SUBJECT: Award of Contract No. 1717-003-11

2018 Traffic Signal Program

RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract No. 1717-003-11 to Crown Contracting Limited in the amount of \$4,430,632.76, (including GST), for traffic signal and crosswalk improvements at various locations throughout the City;
- 2. Set the expenditure authorization limit for Contract No. 1717-003-11 at \$4,880,000.00, (including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1717-003-11.

SCOPE OF WORK

The construction package related to this Contract consists of the installation of 10 new Traffic Signals, Pedestrian Signals and Special Crosswalks and the refurbishment of 7 Traffic Signals at the locations listed in the following table, which are also illustrated on the map attached to this report as Appendix "I":

The Contract work is expected to start May 22, 2018 and be completed by October 12, 2018.

TENDER RESULTS

Tenders for the subject Contract were opened on April 6, 2018 with the following results:

The Engineer's (WEB Engineering Ltd.) pre-tender estimate was \$4.2 million, (including GST).

EVALUATION

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. All submissions included the required 10% bid bond, were signed on the Tender Form, and were initialed on the Summary Sheet of the Schedule of Quantities and Prices.

The low bidder, Crown Contracting Limited, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 100 working days, as stipulated in the Contract. Their past performance on similar work has been satisfactory and they have no outstanding legal claims against the City. It is recommended that Crown Contracting Limited be awarded Contract No. 1717-003-11.

SUSTAINABILITY CONSIDERATIONS

This project supports the objectives of the City's Sustainability Charter 2.0. In particular, this project relates to the Sustainability Charter 2.0 theme Infrastructure. Specifically, this Contract supports the following Strategic Directions (SD) and Desired Outcomes (DO):


Funding for this Contract is available in the approved 2018 Transportation Budget.
