SUBJECT: Sponsorship Request - Indo-Canadian Dental Association

#### RECOMMENDATION

The Finance Department recommends that Council:

- Receive this report for information; and
- 2. Approve a sponsorship contribution of \$2,500 from the Council Initiatives Fund to the Indo-Canadian Dental Association ("ICDA") in support of their 2<sup>nd</sup> Annual Gala being held on Saturday, June 16, 2018.

#### **INTENT**

The City has received a request from the ICDA, for a sponsorship in support of their 2<sup>nd</sup> Annual Gala that will be held on Saturday, June 16, 2018 at the Sheraton Guildford Hotel in Surrey. This report addresses that request.

#### **DISCUSSION**

The ICDA is a non-profit organization committed to promoting and raising funds for oral health care in the community. In 2017, the ICDA hosted their inaugural gala to celebrate the inception of the organization and raise funds to support the BC Oral Cancer Prevention Program. The ICDA has successfully hosted free oral cancer screening events for the City of Surrey since 2016. The screening event aims to detect early stages of cancer and educate the community in cancer prevention. Over the past two years, more than 400 patients have benefited from the cancer screening events.

The 2<sup>nd</sup> Annual Gala will include fundraising initiatives and all proceeds from the gala will be donated towards the British Columbia Oral Cancer Prevention Program. The ICDA and BC Oral Cancer Prevention Program are planning to establish their first satellite clinic in Surrey. This clinic will act as a triage for patients with high risk oral lesions so they can be diagnosed at an early stage.

Staff has evaluated the request and supports a sponsorship of \$2,500 from the Council Initiatives Fund, which will include a table for 10 at the Gala and recognition during the event. Details of the sponsorship are included in Appendix "I".

#### **FUNDING**

Appendix "II" attached to this report documents the balance in the Council Initiatives Fund based on an assumption that Council will approve the recommendations of this report.


#### **CONCLUSION**
