**Pedestrian Signals and Road Improvements** 

# RECOMMENDATION

The Engineering Department recommends that Council:

- 1. Award Contract No. 1718-025-11 to TAG Construction Ltd. ("TAG") in the amount of \$1,612,267.65, (including GST), for the construction of pedestrian signals and road improvements at various locations throughout the City;
- 2. Set the expenditure authorization limit for Contract No. 1718-025-11 at \$1,775,000.00, (including GST and contingency); and
- 3. Authorize the General Manager, Engineering to execute Contract No. 1718-025-11.

#### **SCOPE OF WORK**

The construction package related to this Contract consists of installation of pedestrian signals and minor road improvements at the three locations listed in the following table and illustrated on the map attached to this report as Appendix "I".

The Contract work is expected to start on July 9, 2018, and be completed by November 2018.

#### TENDER RESULTS

Tenders for the subject Contract were advertised on BC Bid and were opened on June 5, 2018 with the following results:

The Engineer's (Aplin & Martin Consultants Ltd.) pre-tender estimate was \$1,685,195.00 (including GST).

## **EVALUATION**

The City's consultant reviewed the tender submissions for accuracy and completeness. No errors were found. The submission included the required 10% bid bond, was signed on the Tender Form, and was initialed on the Summary Sheet of the Schedule of Quantities and Prices.

Only one bid was received on this Contract. Staff spoke with various contractors during the tendering period and was advised that some do not have the capacity to undertake additional work at this time and that some were not likely to submit as they were awaiting the results on other project bids with other local governments; however, staff elected to continue with this tender as not all contractors who may be interested are known to the City and staff were also hopeful that those who were awaiting the results on their project bids with other local governments were not successful in their bids.

The sole bidder, TAG, has provided a Consent of Surety for a Performance Bond and a Labour & Materials Bond, and agreed to complete the work within 75 working days, as stipulated in the Contract. TAG's past performance on similar work has been satisfactory. They have no outstanding legal claims against the City. It is recommended that TAG be awarded Contract No. 1718-025-11.

#### SUSTAINABILITY CONSIDERATIONS

The work of this Contract supports the objectives of the City's Sustainability Charter 2.0. In particular, this work relates to the Sustainability Charter 2.0 theme of Public Safety and Infrastructure. Specifically, this project supports the following Desired Outcomes ("DO") and Strategic Direction ("SD"):

- Transportation Safety DO 09: Transportation network supports and provides safe mobility for all ages and abilities;
- Transportation Safety DO 10: Surrey is part of a coordinated effort to reduce risk of harm for all road users, with attention to those who are most vulnerable, including pedestrians and cyclists; and
- Transportation SD 11: Ensure the delivery of safe and accessible infrastructure, programs and education to support walking, cycling and transit for all residents.


## **FUNDING**
